SUBJECT: Classroom Site Fund Allocation

The FY 2012 Classroom Site Fund (CSF) payment calculations were projected to be \$219.00 per weighted attending student count by the Joint Legislative Budget Committee (JLBC). Of the \$219.00, \$120.00 should be used for new FY 2012 budget capacity. The remaining balance will be used for prior year shortfalls.

School Finance has completed the FY 2012 CSF payment #5 calculations. Actual receipt of the CSF payment by counties/districts and charters is scheduled for Friday, December 16, 2011.

The report detailing the counts and weights used to determine the Classroom Site Fund allocation will be available on Friday, December 16th at http://www.ade.az.gov/districts. Each district and charter will have received a proportionate share of CSF revenues (\$113,983,299), based on their proportionate share of the state total weighted count. All monies received for the Classroom Site Fund to date have been distributed based on each district's or charter's weighted attending student count.
