# COLLIN COUNTY COMMUNITY COLLEGE DISTRICT BOARD OF TRUSTEES

#### **Meeting Minutes**

May 24, 2016

The Collin County Community College District ("Collin College," "Collin," or "District") conducted its regular monthly Board of Trustees meeting on Tuesday, May 24, 2016, in the Board Room 139 at the Collin Higher Education Center (CHEC), with Chairman J. Robert Collins presiding. Trustees in attendance were Ms. Stacy Anne Arias, Mr. Andy Hardin, Mr. Mac Hendricks, Ms. Jenny McCall, Mr. Jim Orr, Mr. Adrian Rodriguez, Mr. Larry Wainwright, and Ms. Nancy Wurzman. Other attendees included District President H. Neil Matkin, Collin College administrators, faculty, students, staff, community members, and vendor representatives.

#### **CALL TO ORDER**

Chairman Collins called the May 24, 2016, meeting of the Board of Trustees of Collin County Community College District to order at 5:34 p.m. The Board met at the Collin Higher Education Center, 3452 Spur 399, McKinney, TX 75069.

#### ADJOURNMENT TO CLOSED OR EXECUTIVE SESSION

Trustee Hendricks recessed the meeting to closed session at 5:35 p.m. in the Board Conference Room 135, as authorized by Article 551.001, Texas Government Code, Sections 551.071 Consultations with Attorney; 551.072 Deliberations about Real Property; and 551.074 Personnel Matters.

2016-5-2-2 Report Out of Budget and Finance Committee: First Reading of Policy CAK
Budget and Finance Committee Chair Mac Hendricks said the committee met earlier in the
day and discussed changes to policy CAK: Appropriations and Revenue Sources —
Investments. He said the proposed changes redefine what the college could invest its funds
in including CDs; bonds; state, federal, and local sources; and other. Investment income
could increase by half a million dollars per year.

Mr. Hendricks reported that the Budget and Finance Committee recommends the changes as presented to Policy CAK: Appropriations and Revenue Sources – Investments for first reading. This being a first reading, no action was required nor taken.

**2016-5-2-3** Report Out of Budget and Finance Committee: First Reading of Policy CF Budget and Finance Committee Chair Mac Hendricks said the committee also discussed changes to policy CF: Purchasing and Acquisition. He said the proposed changes increase the threshold for board approval of annual spending or contract amount from \$25,000 to \$50,000. Mr. Hendricks said due diligence by the staff will still be in place.

Mr. Hendricks reported that the Budget and Finance Committee recommends the changes as presented to Policy CF: Purchasing and Acquisition for first reading. This being a first reading, no action was required nor taken.

#### 2016-5-2-4 Approval of Amendment to FY16 Budget

This request for a budget amendment reflects the additions to restricted revenues and expenses as a result of amendments, new awards, and the carryover of prior year's unspent grant budgets that may be utilized in the current year budget for the remainder of the fiscal year. Grant additions for May 2016 totaled \$178,538.

On motion of Mr. Orr, second of Ms. Arias, the Board of Trustees of Collin County Community College District unanimously approved an amendment to the FY16 budget for changes in Budgeted Restricted Revenue and Expenses for Grants for the remainder of the fiscal year ending August 31, 2016 as presented.

### <u>2016-5-2-5</u> Approval of Cooperative Purchasing Agreement with College of the Mainland

An agreement pursuant to the authority granted by Section 271.102 Local Government Code allows local governments to pursue mutually beneficial and cooperative purchasing programs. This is an ongoing agreement activated only by the District's issuance of a Purchase Order. College of the Mainland has requested to participate in a contract solicited and awarded by Collin County Community College District. This agreement will allow College of the Mainland and Collin County Community College District to participate in competitively solicited contracts that have been awarded by one another.

On motion of Mr. Rodriguez, second of Ms. McCall, the Board of Trustees of Collin County Community College District unanimously approved the Cooperative Purchasing Agreement between College of the Mainland and Collin County Community College District.

## <u>2016-5-2-6 Approval for the District President to Negotiate and Execute Contract for Bookstore Management Services</u>

The College issued RFP 3945 to obtain proposals for Bookstore Management Services. The contract for bookstore management services will provide lower costs for Collin students and increase dollars to the college. Approval of this item allows the District President to negotiate and execute a contract to begin in late summer with an initial term not to exceed five (5) years and containing a mutual option to extend for an additional five (5) year term.

On motion of Mr. Rodriguez, second of Mr. Wainwright, the Board of Trustees of Collin County Community College District unanimously approved authorizing the District President to negotiate and execute a contract for Bookstore Management Services to begin in late summer 2016 for an initial five (5) year contract term with a mutual option to extend for an additional five (5) year term.

## <u>2016-5-2-7 Approval of Second Amendment of the Interlocal Cooperation Agreement with the City of Richardson</u>

In May 2014, the Board of Trustees of Collin County Community College District approved an Interlocal Cooperation Agreement with the City of Richardson for the use of the City's Fire Training Center while the college is in the process of constructing a new facility. A first amendment of this agreement was approved in July 2015 and will expire in May 2016. A second amendment is requested to expire in May 2017.

On motion of Mr. Orr, seconded by Ms. Wurzman, the Board of Trustees of Collin County Community College District unanimously approved the renewal of the Interlocal Cooperation Agreement with the City of Richardson for use of the City's Fire Training Center ending May 2017.

### 2016-5-8 Approval of Bid Report for May 2016

Acting Vice President/CFO Ken Lynn presented the Bid Report for May 2016 with five (5) new solicitations in the amount of \$817,262.64, two (2) contract renewals equaling \$80,000.00, and two (2) contract revisions totaling \$134,024.00. The Bid Report for May 2016 totaled \$1,031,286.64.

Executive Vice President Brenda Kihl presented information about Bid Request #3 for the purchase of digital commons and selected works from Berkeley Electronic Press to be managed by the Spring Creek Campus Library. Dr. Kihl said the digital commons and selected works provide a hosted platform to store and publish scholarly and creative works by students, faculty, and staff while the District retains ownership of these works. A discovery tool is included for internet searches, the software platform, training, and support necessary to showcase the District's presence globally.

Spring Creek Campus Library Executive Director Linda Kyprios said one of the interesting features of the digital commons is that Collin will be able to see the location of people who are downloading Collin materials. She said the target implementation date is fall 2016. The estimated three (3) year expenditure is \$98,968.00 and will be funded through the Innovation Challenge.

On motion of Ms. Arias, second of Mr. Rodriguez, the Board of Trustees of Collin County Community College District unanimously approved the Bid Report for May 2016.

#### **DISTRICT PRESIDENT'S AND BOARD ANNOUNCEMENTS**

Comments on Workshops, Seminars, and Conferences taking place at the College; Awards Received; Accomplishments, Appointments at the Local, State, and National Level; Published Articles and Newspaper Reports; College Reports/Metrics and Upcoming Events.

#### **District President Matkin announced the following:**

1. Ann Beheler, Executive Director of Emerging Technology and Grants at Collin College, has been invited to attend the Knowledge Exchange on Undergraduate STEM Education, June 15 in Alexandria, Virginia. The event is being presented by the National Science Foundation in collaboration with the White House Office of Science and Technology Policy and the Subcommittee on Federal Coordination in STEM education. The knowledge

exchange is a one-day event intended to bring together high-level researchers, experts, and other federally funded stakeholders in improving undergraduate STEM education. Beheler has been nominated to lead a discussion group regarding science, technology, engineering, and math education related to community colleges.

- 2. Dozens of students from Bowman, Otto, and Wilson Middle Schools in Plano participated in the district's annual Science Day, which seeks to pique students' interest in science and math-related subjects. The event, held April 16, was open to parents, teachers, students, and siblings. During Science Day, students participated in experiments and were exposed to several areas of science and math. Thank you to Vice President/Provost Mary McRae, Dean Cameron Neal, Organizers/Professors Cathy Donald-Whitney and Deborah Cardenas, all of the presenters, and others who help make this a successful ongoing outreach to young students.
- 3. Several Collin College graduates are performing in some of the hottest shows on Broadway right now. Elizabeth Judd is a cast member in "Hamilton," while Ragan Pharris performs in "Waitress." Former students Akron Watson and Cory Boulieris are performing in "The Color Purple" and "She Loves Me" respectively. Congratulations to these students on making their dreams come true.
- 4. Dr. Abe Johnson has been named to the Texas Higher Education Coordinating Board Health Science Program of Study Career Cluster Advisory Committee. Dr. Johnson is Vice President/Provost of the Preston Ridge Campus. He was formerly the dean of health sciences, biology, chemistry, emergency services, and physical education at Central Park Campus.
- 5. Professor Marti Miles-Rosenfield has been named president-elect of the Texas College Reading and Learning Association (TxCRLA). Miles-Rosenfield is a professor of developmental writing at Spring Creek Campus.
- 6. The All College Council donated 443 boxes of food and supplies collected from faculty, staff, and students during its Meals on Wheels Spring Box Collection. There were so many contributions that Meals on Wheels had to make two trips to pick up all of them. Thank you to the Meals on Wheels Committee, the All College Council and Chair G'Anna Saunders, and the faculty, staff, and student volunteers. - 7. McKinney ISD presented Collin College with an Outstanding Business Partner Award at its "District VIPS Appreciation Luncheon" on May 19. The annual event recognizes volunteers from each of the ISD's campuses and honors dynamic, innovative, and rewarding business partnerships.
- 8. The final figures are in from last month's inaugural Cougar Run 5K and Fun Run. The run took in \$20,980 in gross revenue, including in-kind sponsorships. Net revenue was \$13,589, which provides enough money for about nine full scholarships for the 2016-17 academic year.
