

# **SUPPLEMENTAL LEVY ELECTION RESOLUTION**

**JOINT SCHOOL DISTRICT #331  
MINIDOKA, CASSIA, JEROME AND LINCOLN COUNTIES**

## **A RESOLUTION CALLING FOR SUPPLEMENTAL LEVY ELECTION**

WHEREAS, in accordance with Section 33-802 (3), Idaho Code, as amended, the Board of Trustees of Joint School District No. 331, Minidoka, Cassia, Jerome and Lincoln Counties, Idaho (the "District") has determined there is a need for a Supplemental Levy in the amount of \$2, 225,000 per year for two (2) years, for the purpose of paying all lawful expenses of maintaining and operating the District for the fiscal year(s) beginning July 1, 2018, and ending June 30, 2020.

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of Joint School District No. 331, Minidoka, Cassia, Jerome and Lincoln Counties as follows:

- SECTION 1. That a supplemental levy election be and the same is hereby called to be held in the District on Tuesday, November 7, 2017 for the purpose of submitting to the qualified electors of the District the question set out in the form of the ballot appearing in Section 3 hereof.
- SECTION 2. That on November 7, 2017 said election will be conducted by the Minidoka County Elections Department pursuant to and in accordance with Title 34 Idaho Code.
- SECTION 3. That voting at said election shall be by secret and separate ballot, and the ballot shall be prepared by the Clerk of Board and shall be provided in substantially the following form:

**QUESTION:** Shall the Board of Trustees of Joint School District No. 331, Minidoka, Cassia, Jerome and Lincoln Counties, Idaho be authorized and empowered to levy a Supplemental Levy in the amount of Two Million two hundred twenty five thousand and no/ dollars (\$2,225,000) per year for two (2) years, commencing with the fiscal year beginning July 1, 2018 and ending June 30, 2020, for the purpose of financing any lawful expenses of maintaining and operating the District; all as provided in the Resolution adopted by the Board of Trustees on July 17, 2017.

If you, by mistake or accident, mark, tear, deface, or otherwise mutilate this Ballot, return it to the Election Judges and obtain another Ballot.

- SECTION 4. That the Clerk of the Board of Trustees shall convey to the Minidoka County Elections Department the Official Ballot, set forth in Section 3, above, and the Notice of Election, appearing in Section 6 hereto, for publication pursuant to and in accordance with Title 34 Idaho Code.
- SECTION 5. That the County Commissioners shall act as the canvassing board pursuant to and in accordance with Title 34 Idaho Code and will convey the result to the Minidoka Jt. School District Board of Trustees as set forth therein.
- SECTION 6. That the Notice of Election shall be prepared by the Clerk of the Board of Trustees and shall be provided in substantially the following form:

**NOTICE OF SUPPLEMENTAL LEVY ELECTION**

Notice is hereby given that pursuant to the laws of the State of Idaho and the Levy Election Resolution of the Board of Trustees of Joint School District No. 331, Minidoka, Cassia, Jerome and Lincoln Counties, Idaho, adopted on July 17, 2017 a Supplemental Levy Election will be held on November 7, 2017, between the hours of 8:00 a.m. and 8:00 p.m. for the purpose of voting upon the following question and proposition of authorizing a levy:

QUESTION: Shall the Board of Trustees of Joint School District No. 331, Minidoka, Cassia, Jerome and Lincoln Counties, Idaho be authorized and empowered to levy a Supplemental Levy in the amount of Two million two hundred twenty five thousand and no/dollars (\$2,225,000) per year for two (2) years, commencing with the fiscal year beginning July 1, 2018 and ending June 30, 2020, for the purpose of financing any lawful expenses of maintaining and operating the District; all as provided in the Resolution adopted by the Board of Trustees on July 17, 2017.

Notice is further given that only qualified electors of the District, eighteen (18) years of age or older, who have resided in the District for thirty (30) days preceding the Levy Election, who are registered or who register at the polls on the day of the Levy Election, as provided by law, are entitled to vote at said election.

Any registered elector of the District may make written application to the County Clerk in accordance with law for an absentee ballot, provided that an absentee ballot must be received by the County Clerk no later than 8:00 p.m. on the day of the election in order to be counted.

If at said Supplemental Levy Election a simple majority of the qualified registered electors eighteen (18) years of age or older voting at such election assent to the

Supplemental Levy for the purpose of financing all lawful expenses of maintaining and operating the schools and facilities of the District, such levy shall be certified and shall become effective, as provided by the Idaho Code.

SECTION 7. That no person shall vote at such Supplemental Levy Election who is not at the time a Qualified Elector as set forth in Titles 33 and 34 Idaho Code.
