

## **RESOLUTION DESIGNATING DISTRICT'S ELECTION REPRESENTATIVE**

### **WHEREAS:**

1. The biennial election of the Board of Kalamazoo Regional Educational Service Agency, Michigan (the "KRESA Board") will be held on Monday, June 1, 2015; and
2. The members of the KRESA Board will be elected by an electoral body composed of one (1) person designated by the board of each of the constituent school districts; and
3. In accordance with Section 614(2) of the Revised School Code, MCL 380.614(2), this Board desires to designate Carol Lohman as this District's proposed representative and Wil Emmert as an alternate designated representative in the event the designated representative is unable to attend and further desires to direct said representative and alternate to vote on behalf of this Board for a specific candidate.

### **NOW, THEREFORE, BE IT RESOLVED THAT:**

1. This Board does hereby approve the designation of Carol Lohman as the representative of this Board for the electoral body, which body will elect one (1) [insert number of vacancies] candidates to the vacancies on the KRESA Board on Monday, June 1, 2015 and Wil Emmert as an alternate in the event the designated representative is unable to attend.
