Lincoln Elementary School Family Engagement Policy

Part 1. GENERAL EXPECTATIONS

Lincoln Elementary School agrees to implement the following statutory requirements:

- Parent suggestion opportunities at meetings
- Planned parent/family activities

Lincoln Elementary School will provide each parent an individual student report about the performance of their child on the State assessment in math, language arts and reading by: IAR (Illinois Assessment of Readiness) Reports and MAP Reports

7. Lincoln Elementary School will take the following actions to provide each parent timely notice when their child has been assigned or has been taught for four (4) or more consecutive weeks by a teacher who is not highly qualified within the meaning of the term in section 200.56 of the Title 1 Final Regulations (67 Fed. Reg. 71710, December 2, 2002) by: (see appendix A)

- 8. Lincoln Elementary School will provide assistance to parents of children served by the school, as appropriate, in understanding topics by undertaking the actions described in this paragraph
 - the state's academic content standards,
 - the state's student academic achievement standards
 - the state and local academic assessments including alternate assessments
 - the requirements of Part A
 - how to monitor their child's progress
 - how to work with educators:
 - School District Website,
 - Links to ISBE
 - Educational Websites
 - Assessment Reports
 - Parent Newsletters, by handouts, or by district website
- 9. Lincoln Elementary School may provide materials and training to help parents work with their children to improve their children's academic achievement, such as literacy training, math resources, and using technology, as appropriate, to foster family engagement.
- 10. Lincoln Elementary School may, with the assistance of its parents, educate its teachers, pupil services personnel, principals and other staff in how to reach out to, communicate with, and work with parents as equal partners in the value and utility of contributions of parents, and in how to implement and coordinate parent programs and build relationships between parents and schools, by:
 - A Title I parent coordinator will organize parent and family activities
