AGENDA ITEM: Consider Approval of House Bill 3834 Certification for Local Governments and Authorize Submission of Compliance with Cybersecurity Training Requirements

PRESENTER: Brooks Moore, Director of Technology

BACKGROUND INFORMATION:

- House Bill 3834 requires all state and local government employees, and elected officials, who have access to a computer system to complete a cybersecurity training program.
- Section 2054.5191, Government Code, requires the governing body of a local government to verify and report on the completion of the cybersecurity training and requires periodic audits to ensure compliance with this section.
- Pursuant to the requirements of House Bill 3834, districts are required to submit documentation certifying that the appropriate employees and elected officials have completed the training requirements.
- For the current fiscal year, the cybersecurity training must be completed by June 14, 2020 with the compliance/certification report submitted by June 15, 2020.
- Aledo ISD selected the KnowBe4 training program to meet the requirements of House Bill 3834.
- All required district employees and elected officials will have completed the cybersecurity training by the June 14, 2020 deadline.
