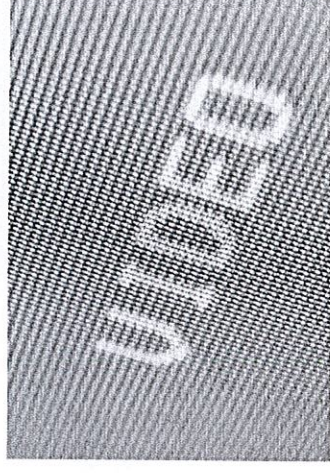

It is a video distribution system that allows messages, instructional videos, electronic lesson plans, and instructional programs on cable, etc., to be broadcast to all classroom televisions, video projectors, and interactive flat panels throughout the campus using the district's wide area network.
