Co-op Sponsorship of Boys Golf and Girls Gymnastics with Pacelli

BACKGROUND: The MSHSL offers the option for member schools to form cooperative sponsorships between member schools in high school athletics is an agreement where two or more schools combine their student-athletes to form a single team in a particular sport. This is usually done when one or more of the schools do not have enough participants to field a team on their own. The AHS Activities Director met with Pacelli Athletic Director, Principal, and Superintendent to discuss current cooperatives and the possible addition of two: Boy's Golf and Girls Gymnastics. Both schools agreed to the co-op sponsorship.

RATIONALE: The reasoning behind the conversation with these 2 sports in particular was due to students at Pacelli who are interested in participating. Boy's Golf is in the highest section placement for the MSHSL and adding a co-op, so we support the opportunity to help grow the game of golf. For gymnastics, the reason is twofold: 1) AHS enrollment has moved our gymnastics program up a competitive class, and 2) Our participation numbers for gymnastics are in the single digits. We need to look to grow our program so it can remain sustainable.

RECOMMENDATION: The recommendation to the board is to add the cooperative sponsorships of Boys Golf and Girls Gymnastics with Pacelli Catholic Schools.
