QUALIFICATIONS AND DUTIES OF THE SUPERINTENDENT

As chief administrator of MESD the Superintendent shall perform, or cause to have performed, the following:

- 1. Administration of MESD to conform with state and federal statutes, state administrative rules, Board policy, court decisions and the requirements of the collective bargaining agreements;
- 2. Development and implementation of administrative regulations and procedures as are necessary to faithfully carry out the intent of Board policy;
- 3. Operation of MESD within the appropriations set for each fund;
- 4. Proposal of new Board policies, or changes in adopted Board policies, consistent with the best interest of MESD;
- 5. Provision of information to the Board relative to all matters coming before it;
- 6. Submission of employment and/or termination recommendations to the Board in matters relating to contracted personnel;
- 7. Employment/termination/assignment decisions in matters relating to non-contracted personnel;
- 8. Decisions regarding employment/termination/assignment/discipline/transfer and evaluation of classified employees;
- 9. Decisions regarding employment/termination/assignment/discipline/transfer and evaluation of contracted employees;
- 10. Decisions regarding financial settlements where the settlement amount is \$15,000 or less. All settlements will be reported to the Board.
- 11. Act as the liaison between the staff and the Board.
