**WHEREAS** the Goose Creek Consolidated Independent School District (School District) hereby gives notice that Goose Creek Consolidated Independent School District will conduct an election on May 3, 2025, 7:00 a.m. to 7:00 p.m. to fill the expiring terms of four (4) Single-Member Districts of the Goose Creek CISD Board of Trustees.

The Goose Creek Consolidated Independent School District is in Harris County. The election in Harris County of the Goose Creek CISD shall be administered by Harris County and conducted as a joint election with Harris County in precincts that may be served by common polling place pursuant to Chapter 271 of the Texas Election Code. All election judges, alternate judges, clerks, members of the early voting ballot board, central counting station officials, and other personnel designated by the county to conduct the election in Harris County precincts are hereby appointed and confirmed.

**APPLICATIONS FOR MAIL BALLOTS** may be submitted no earlier than Wednesday, January 1, 2025, nor later than the closing of business on Tuesday, April 22, 2025; **note the application must be received and not postmarked by that date.** Federal Post Card Application (FPCAs) must be received no later than the close of business on Tuesday, April 22, 2025. Residents applying for a ballot by mail shall send their applications as specified below.

**Please note:** If an Application for Ballot by Mail is **FAXED OR EMAILED**, then the original hard copy of the application **MUST** be mailed and received by the Early Voting Clerk no later than the 4<sup>th</sup> business day after the transmission by fax or email. (TEC84.007).

**ALL VOTING** in the election, including early voting by personal appearance in Harris County shall be done using the electronic voting system adopted by the Commissioners' Court of Harris County.

**ELECTION SUPPLIES AND BALLOTS** shall be printed in English, Spanish, Vietnamese, and Traditional Chinese for Harris County. Such election supplies shall include, but not be limited to, all forms, signs, and other materials used by the election judges at all polling locations.

**THE SECRETARY TO THE BOARD OF TRUSTEES** shall cause a notice of said election to be published in a newspaper of general circulation in the Goose Creek Consolidated Independent School District not more than thirty (30) days or less than ten (10) days prior to the Election. Notice of said election shall also be posted not later than the 21<sup>st</sup> day before the election and remain posted continuously through election day on the bulletin board used for notices of meetings of the Board of Trustees. Additionally, copies of this Order and the Notice of Election shall be posted on the District's website. The Secretary of the Board of Trustees, or his/her designee, shall deliver notice of this election to the Harris County Clerk not later than the 60<sup>th</sup> day before the election (March 4, 2025).

**THE BOARD OF TRUSTEES** shall canvass the returns of the election and not earlier than the third (3<sup>rd</sup>) day nor later than the (11<sup>th</sup>) day after Election Day. The canvass may not be conducted until the Ballot Board has verified and counted all ballots cast at election locations, all provisional ballots (if a provisional ballot has been cast in the election), and all timely received ballots cast from addresses outside the United States.

**SAID ELECTION** shall be beheld in accordance with the laws of the Texas Election Code, the Texas Education Code, the Texas Constitution and the Federal Voting Rights Act of 1965 as amended. Such election shall be held by election officials appointed by Harris County Commissioners' Court, or its designee, for voters of Harris County.
