Public Hearing for Texas Academic Performance Report (TAPR) Dr. Mike Mattingly, Associate Superintendent for Curriculum & Instruction presented the annual 2022 Texas Academic Performance Report (TAPR) that is provided to each public school district from the Texas Education Agency. The **Texas Academic Performance Reports (TAPR)** pull together a wide range of information on the performance of students in each school and district in Texas every year. Performance is shown disaggregated by student groups, including ethnicity and socioeconomic status. The reports also provide extensive information on school and district staff, programs, and student demographics.

The TAPR report includes the following:

- Attendance;
- Graduation;
- Dropout;
- Graduation Profile;
- College, Career, and Military Readiness;
- STAAR and EOC Performance;
- Student Demographics;
- Teacher Demographics; and,
- Staff Information.

Dr. Mattingly gave an overview of student performance for Denton ISD, the class of 2020-2021 school year which had a total of 2095 graduates and the credit for College, Career & Military Readiness (CCMR) credit was 62.3%. The District's graduation rate for 2021 was 97% and the attendance rate for 2021 was 97%.

President Price opened the public hearing at 7:00 pm and asked for comments and no one wished to speak.

Citizen Advisory Committee Bond Presentation Dr. Lizzy Johnson, CEO of Transcend4 provided the District with bond facilitation services. The District's Citizen's Bond Advisory committee was made up of over 100+ citizens and students. The committee members participated in six committee meetings where they were presented with

information regarding, school finance, transportation, demographics, needs assessment, safety and security and technology and infrastructure.

Andrew Morris and Aimee Jones two of the committee members along with two student representatives spoke about their committee experience and the committee's charge when developing the bond package.

Discussion of Denton ISD Health & Wellness Clinic Chris Bomberger, Executive Director of Risk Management provided the Board of Trustees with an overview of a district-sponsored medical clinic.
