**Topic:** Recommendation for Contract Award: Project A – Cabling (FCC Form 470 #260005727)

## Background and Rationale:

To support infrastructure upgrades for Funding Year 2026, Hallsville Independent School District conducted an E-rate compliant competitive bidding process for Project A – Cabling (Form 470 #260005727). Following a fair and open review period, a cross-department evaluation committee analyzed six submitted proposals.

## Selection Criteria and Financials:

In accordance with E-rate rules, the Price of Eligible Goods & Services was the most heavily weighted factor in the selection process. However, to ensure a high-quality, long-term solution, the committee also evaluated vendors on service history, technical expertise, and project understanding.

The evaluation committee identified **J&L Tech** as providing the best overall value to the district.

- Total Proposal Amount: \$25,000.
- Anticipated E-rate Reimbursement: 60%.


