RESOLUTION FOR RATIFYING AND CONFIRMING
PUBLICATION OF LEGAL NOTICE AND SETTING OF BUDGET HEARING
AND ADOPTION OF FY25 BUDGET

WHEREAS, the Board of Education (hereinafter “Board”) of Benjamin School District No. 25, DuPage County, Illinois (hereinafter “School District”) is authorized by Section 17-1 of *The School Code*, 105 ILCS 5/17-1, to adopt and file with the Illinois State Board of Education an annual budget before or within the first quarter of its fiscal year beginning July 1, 2025 and ending June 30, 2026;

WHEREAS, the Board of Education of Benjamin School District No. 25, DuPage County, Illinois, caused to be prepared in tentative form a budget, and the Secretary of this Board has made the same conveniently available to public inspection for at least thirty (30) days prior to final action thereon;

WHEREAS pursuant to Section 17-1 of the *School Code*, notice of a tentative budget’s availability for public inspection and of the public hearing was published, in a newspaper published in the School District, at least thirty (30) days prior to the final action thereon; and

WHEREAS, a legal notice, as seen in "Exhibit 1", attached hereto, and published in a local newspaper of general circulation (The Daily Herald) on August 1, 2025, and August 8, 2025, is hereby ratified and confirmed; and

WHEREAS, the presentation and approval of the tentative budget at the Regular Board Meeting on August 11, 2025, is hereby ratified and confirmed; and

WHEREAS, the tentative budget, presented as the final budget, and the related budget hearing held at the Regular Board Meeting on September 15, 2025, at approximately in the District Administrative Service Center Board Room, as described in "Exhibit 1", is hereby ratified and confirmed.

NOW THEREFORE, BE IT RESOLVED by the Board of Education of Benjamin School District No. 25, DuPage County, Illinois as follows:

Section 1: the budget containing an estimate of amounts available in each Fund, separately, and of expenditures from each Fund be and the same is hereby adopted as the final balanced budget of this school district for said fiscal year.

Section 2: The balanced final budget attached hereto as Exhibit 2 and incorporated herein by reference is hereby adopted as the final balanced budget of the School District for the fiscal year which commenced on July 1, 2025, and will end on June 30, 2026.

Section 3: The Superintendent or his designee shall file copies of this Resolution and Exhibit 2 with the Illinois State Board of Education and the DuPage County Clerk within thirty (30) days after its adoption.

Section 4: This Resolution shall be in full force and effect upon its adoption.


