105 ILCS 5/27-24.2 (23 Ill.Admin.Code Section 252.30(a)(3) (Driver Education Course Fee)

WHEREAS, the Board of Education has previously charged a fee of \$ to students
who participated in the driver education course offered by the District pursuant to a Waiver of the
fee requirement set forth in Section 27-24.2 of the School Code (105 ILCS 5/27-24.2) granted to
the District by the Illinois General Assembly, which Waiver expired at the end of the
school year; and
WHEREAS, Section 27-24.2 of the School Code was amended by Public Act 97-0145,
effective July 14, 2011, to allow the driver education course fee to be increased from \$50 to an
amount not to exceed \$250 by school board resolution following a public hearing on the increase;
and atp.m. on the Administration's request to increase the driver education
course fee from \$50 to an amount not to exceed \$250 by school board resolution; and
WHEREAS proper notice of the public hearing setting forth the data time place and

WHEREAS, proper notice of the public hearing setting forth the date, time, place and general subject matter of the hearing and the proposed amount of the fee the District will request was provided pursuant to Section 2-3.25g (c-5) of the School Code (105 ILCS 5/2-3.25g (c-5)), by posting same on the District's website at www.harlem122.org at least 14 days prior to the public hearing; publishing said notice of public hearing at least 7 days prior to the hearing in a newspaper of general circulation within the school district; and, notifying in writing the affected exclusive bargaining agents and those State legislators representing the District's territory of its intent to seek approval of the modification and of the hearing to be held to take testimony from staff at least 7 days prior to the date of the hearing; and

WHEREAS, the affected exclusive bargaining agents were allowed to attend the public hearing; and

WHEREAS, following the public hearing the Board has determined it is necessary and in the best interests of the School District to increase the District's driver education course fee from \$50 to an amount not to exceed \$250 for students who participate in the course, unless a student is unable to pay for such a course, in which case the fee for such student shall be waived.
