DISCUSSION AND POSSIBLE ACTION

The Board of Trustees will conduct a hearing of a Level III Grievance filed by Chad A. Brit and any other matter related thereto.

Mr. Rodriguez read aloud: For the record my name is Gilbert F. Rodriguez, and I am the President of the Board of Trustees for South San Antonio Independent School District. Today is Monday, April 5, 2021, and the time is 6:02 PM. We are meeting this evening at the South San Antonio Independent School District Administrative Offices. Without objection a recording of this meeting of this hearing is being made to capture an accurate record of the proceedings. I ask that everyone wait to be recognized before speaking. Mr. Chad Brit is represented by Mr. John F. McCormick. The South San Antonio Independent School District Administration is represented by Sanchez & Wilson, which is the general counsel for the school district. The following persons are also present in participating in this hearing; Trustee Mr. Homer Flores, Trustee Ms. Gina Villagomez, Trustee Mrs. Stacey Alderete, Superintendent of Schools Dr. Marc Puig, Trustee Mr. Ernest Arrellano, Trustee Mrs. Connie Prado, we also have our Chief Academic Officer Ms. Theresa Servellon, and Trustee Shirley Ibarra Pena who is participating virtually. The Board shall hear the grievance and may request a response from the Administration. Policy DGBA Local and Legal will control this hearing and the rules for conducting this grievance hearing are as follows: parties will limit their presentation to ten minutes, board members will subsequently have three minutes to ask questions to the grievant and three minutes to ask questions to administration.

John F. McCormick, legal counsel representing Chad A. Brit, and Woody Wilson, representing South San Antonio ISD, were called to present and answer questions related to this item. Grievance concluded in open session at 6: 42 PM.
