CONSULTING AGREEMENT

THIS CONSULTING AGREEMENT (this "Agreement") made and entered into as of 9/10/24 by and among the Nova Classical Academy (the "School District") and #SocialSchool4EDU (Consultant).

RECITALS

A. The School District desires to engage Consultant in a consulting capacity and Consultant desires to accept such engagement pursuant to the terms and conditions of this Agreement.

AGREEMENTS

- 1. <u>Consulting Services</u>. During the Consulting Period (as defined below), Consultant shall perform and discharge the required duties and responsibilities as outlined in attached Appendix A. Consultant shall provide such Consulting Services in a professional, competent, and timely manner. All financial information is confidential.
- 2. <u>Consulting Period.</u> The term of Consultant's engagement is 2 years and 7 months and shall start on 12/1/24 and continue through 6/30/27.
- 3. <u>Consultant Fees; Reimbursement for Expenses.</u>
 - a. <u>Consulting Fees.</u> In consideration of Consultant's performance for the Consulting Services during the Consulting Period, Consultant shall earn \$9,500 per year with payment due per the schedule below. This reflects a discount of \$1,000 per year due to the 2-year-7-month contract.
 - b. <u>Reimbursement for Expenses</u>. Consultant's expenses are included in the base fee above. Expenses outside of consultant's services will be agreed upon upfront with e-mail approval.
- 4. <u>Consultant working hours.</u> Consultant will commit to dedicating the time and effort necessary to meet the objectives outlined on the attached exhibit. Consultant will work primarily off site.
- 5. <u>Early Termination:</u> You can terminate the contract at any point. If you break the contract before the 2-year-7-month term, your school will owe the additional \$1,000 per year pro-rated.

Scope of Service: Social Media Management

- 4. Minimum of quarterly reviews to discuss social media efforts.

Cost of Service:

- 1. \$5,542 for the first 7 months of service (12/1/24 6/30/25) due by 12/30/24.
- 2. \$9,500 for the remaining 2 years of service (7/1/25 6/30/27) due by 7/30/25 and 7/30/26.
