### **BACKGROUND:**

Since 2000 MEND (Mind, Exercise, Nutrition...Do it!) is an evidence-based family program for overweight youth 6–13-year-old. MEND developed programs and services that empower children and their families to improve their health, improve their fitness and self-esteem. MEND offers quality programs with the flexibility to choose the model that is right for the families, it introduces the families into a healthy lifestyle and weight management program. MEND provides ongoing communication and support with the enrolled families, provides training to BISD staff/faculty, parents and board members upon request. It also provides all materials and teaching aids required to run program as well as all equipment. Brownsville ISD will provide the referrals to the MEND program, the space twice a week, two-hour (afterschool or Saturday) this would include space and access to a gymnasium or outdoor open play space area for exercise. Brownsville ISD will work with UT School of Public Health/MEND staff to set up a system of direct referrals in the program to encourage qualifying children and their families to participate in the free program.

# Memorandum of Understanding Between The University of Texas Health Science Center at Houston, on behalf of its School of Public Health's/MEND Youth Obesity Program

# And Brownsville Independent School District

### Background

The MEND program is an evidence-based family focused program for overweight and obese youth 6-13 years old being offered in the Rio Grande Valley. The program is free to participants and will provide a personal approach through education, skill building, and support to help them live a healthy life! Referrals for this program come from clinics, schools and community-based organizations. Some schools and organizations will also host the program for the 10-week intervention sessions.

This Memorandum of Understanding is between The University of Texas Health Science Center at Houston, on behalf of its School of Public Health's/MEND Youth Obesity Program and Brownsville Independent School District and covers the time-period June 1, 2024 to May 31, 2025. The following agreements guide the collaboration between the two aforementioned organizations during the stated time period.

#### **UT Health will:**

- · Recruit, fund and train employees and contract workers as MEND delivery teams.
- Enroll and obtain consents/liability waivers from participants, children and parents.
- Maintain confidential all participant records in a secure cloud-hosted system.
- Comply with HIPPA requirements.
- · Deliver the 10-week curriculum.
- Provide ongoing communication and support with enrolled families.
- · Complete pre and post measurements/assessments.
- · Enter data into the secure, cloud-hosted MEND database.
- Provide quarterly reports to BISD Health Services regarding referred participants and overall program participant progress and outcomes.
- Maintain support, connection and contact with families 18 months post 1 0-week program through MEND World, graduate support group and MEND family gatherings.
- Communicate on a regular basis with designated BISD representative(s) to insure positive communication and feedback about the program.
- Maintain clean and organized any space provided by BISD for program activities.
- Provide training/information about MEND to BISD staff/faculty, parents and board members upon request.
- Maintain open lines of regular communication with the BISD designated contact, relaying any issues or concerns to them immediately in order to ensure smooth implementation of program.
- Provide all marketing materials: flyers, posters, banners, strategic communications (e.g. letters, brochures, postcards, newsletter articles) to efficiently communicate about the program.
- Provide all materials and teaching aids required by leaders to run the program as well as all equipment (exercise, active play, measuring) required.

### The Brownsville Independent School District (BISD) will:

- Provide referrals to the MEND program through direct referrals, letters/flyers mailed to eligible families, and/or phone calls to students to be determined by the school nurses at
- · BISD Schools.
- Provide the space for twice weekly, two hour (afterschool or Saturday) MEND
  parent/child sessions. This would include classroom space and access to a gymnasium
  or outdoor open play space area for exercise. This availability will be determined by
- · BISD and communicated to MEND staff.
- BISD will maintain open lines of regular communication between its designated contact and the UT School of Public Health/MEND designated contact, relaying any issues or concerns to MEND staff in order to ensure smooth implementation of program.
- BISD will work with UT School of Public Health/MEND staff to set up a system of direct referral into the program (by school nurses) and/or indirect referral (letter to families) to encourage qualifying children and their families to participate in this free program.
