Acidified Mn+2 titration waste	1	1 gallon jug	Solution, approx 3/3 full of waste from potassium permanganate titrations using oxalic acid or ferrous ammonium sulfate, acidified with sulfuric acid

WHEREAS, the Board of Education has the authority, pursuant to Section 5-22,5-23 and 5-24 of the School Code of Illinois (105ILCS 5/5-22,5/5-23 and 5/5-24), to sell any personal property which is not needed for school purposes;

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF EDUCATION OF AURORA EAST SCHOOL DISTRICT NO. 131, KANE COUNTY, ILLINOIS, AS FOLLOWS:

- I. The Board of Education hereby finds and determines that the chemicals that are expired and/or are no longer being used for school purposes, and further finds and determines that it is in the best interests of the District to dispose of or sell such items.
 - 2. The sale of the aforesaid items is hereby authorized and approved, and the Director of Operations, or his nominee, is authorized to take appropriate measures to secure a buyer for such items.
 - 3. The President and Secretary of the Board are authorized and directed to sign and execute such documents as are necessary to consummate the disposal of said items.
- 4. This Resolution shall be in effect forthwith upon its adoption and any prior Resolution or action of the Board inconsistent herewith is hereby repealed to the extent of any inconsistency.
