Re: Transportation Contract

Background:

Firstgroup America Inc., commonly referred to as First Student Bus Company, provides transportation for Bloomingdale School District 13 regular education students. We are currently operating in the fourth extended year of our initial three-year agreement, or in other words, our seventh year. The Illinois School Code 105 ILCS 5/29-6.1 allows for school districts to extend a transportation contract on a year-to-year basis thereafter, so long as the District has not received a timely request for bid from another interested contractor. However, this year the District received unfavorable financial renewal.

Situation:

Because the District received unfavorable contract extension, Bloomingdale School District 13, Medinah School District 11, and Lake Park High School 108 made the decision to bid transportation services. The three districts share services when possible. Pairing the routes in this configuration allows the District to share services and save taxpayers dollars.

The three districts provided a notice to bidders and requested that bid documents be submitted by Tuesday, April 12, 2022 at 10:00 a.m. There were several companies that inquired about the bid process, First Student was the only bidder. As a result of conducting the bid process, First Student lowered its initial offer of 11.0%. The final estimated rates in the bid document were Fiscal Year 2022-23, 8.00%, Fiscal Year 2023-24, 4.00%, and Fiscal Year 2024-25, 4.00%. Lake Park's legal counsel, Robbin Schwartz, has reviewed the contract documents and bid submittals.

For your convenience, I have a contract agreement along with its exhibits.

Recommendation:

The Administration is recommending that the Board of Education approve a 'Student Transportation Services Agreement' with First Student Inc., for the 2022-25 school year.

STUDENT TRANSPORTATION SERVICES AGREEMENT BETWEEN BLOOMINGDALE SCHOOL DISTRICT 13 AND FIRST STUDENT, INC.

IT IS HEREBY AGREED, between the Board of Education of the BLOOMINGDALE ELEMENTARY SCHOOLS DISTRICT 13 with principal offices at 164 South Euclid Avenue, Bloomingdale, Illinois 60108-1634 hereinafter called "DISTRICT" and FIRST STUDENT, INC. hereinafter called "CONTRACTOR" with its corporate offices located at 600 Vine Street, Suite 1400, Cincinnati Ohio, 45202 and its regional operating offices located at 1717 Park Street, Suite 225, Naperville, Illinois 60563 and together called "PARTIES".

WHEREAS, the parties entered into the certain Pupil Transportation Services Bid Agreement dated and submitted on April 12, 2022 (hereinafter the "Agreement") effective July 1, 2022; and all contingencies placed upon the bid specifications.

WHEREAS, the parties desire to further extend the term of the Agreement;

NOW, THEREFORE, the parties mutually agree as follows:

- 1. **Term:** The term of the Agreement shall be for three (3) years commencing July 1, 2022 and continuing through June 30, 2025; thereafter this agreement may be extended on a year-to-year basis by mutual agreement of the parties, subject to the operation of 105ILCS 5/29-6.1.
- 2. **Compensation:** Commencing July 1, 2022, the rates of the compensation payable hereunder during the ensuing contract year shall be set forth in Exhibit A Alternate Bid Form and Exhibit B Charter Rates and are based on the current number of routes.
- 3. **Notices to Parties:** All notices to be given by the parties to this Agreement shall be in writing and serviced by depositing same in the United States Mail, certified mail.
