MINUTES TUPELO PUBLIC SCHOOL DISTRICT SPECIAL MEETING OF THE BOARD OF TRUSTEES

July 31, 2018 FY19 BUDGET PUBLIC HEARING

The Board of Trustees of the Tupelo Public School District convened in open session in a duly called special meeting held as the District's FY 2019 Budget Public Hearing at approximately 5:00 p.m. on Tuesday, July 31, 2018, at the Hancock Leadership Center, 1920 Briar Ridge Road, Tupelo, Mississippi. I. CALL TO ORDER
