Dear Parents of Prospective Las Gatitas:

I am excited that your daughter is interested in trying out for the Celina High School Las Gatitas Drill Team. As the parent of a prospective member, you should be fully aware of the tryout procedure and requirements for drill team membership. You and your daughter must also realize the commitment and dedication requirement of all young ladies once they make Las Gatitas.

Being a member of an organization such as has afforded many young ladies an important opportunity for self-development. While a member of the Las Gatitas, your daughter will develop high goals and standards, maturity, dependability, responsibility, self-development, and life-long memories.

As the sponsor of the Las Gatitas, I have prepared the following outlines to better familiarize you with the tryout procedures and general information concerning the Las Gatitas that must be understood before your daughter tries out. I feel that it is necessary for all drill team candidates to understand exactly what is expected of them should they make the drill team.

1. Tryout Procedure

a. Academic Requirements For Drill Team Membership:

Drill Team candidates will follow the UIL guidelines. If they have failed a class at the 2nd 9 weeks, they must be passing all classes at the last mid UIL grading period as indicated in the UIL documents. They may not have more than one citizenship grade below the S level at the time of tryouts or as their cumulative citizenship average for the academic year. A citizenship grade of U is equivalent to two N's.

b. Requirements for Officer Tryouts:

To be eligible to tryout for an officer position, students must fit the above criteria AND have been a member in good standing the previous football season. Only sophomores or juniors will be eligible to tryout for line officers. Freshman, sophomores, and juniors are eligible to tryout for social officers.

c. Tryout workshop:

This is a one-week period in which senior Las Gatitas Officers and/or senior line members under my supervision, teach a dance routine involving both jazz and high-kick techniques. This routine will be performed before judges on the day of tryouts. The candidates will also be instructed on basic dance technique, style, stretching exercises, kick fundamentals, poise, projection, and showmanship. A candidate must attend the entire workshop and be punctual. If the candidate is absent due to illness, a parent's or Dr.'s note must be presented and she must contact the sponsor before the absence.

d. Judging:

At the end of the workshop, a panel of qualified judges will evaluate each girl's performance. The judges are highly qualified drill team directors or dance teachers. The candidates will try out in a group of three to four girls. Candidates are judged on coordination, rhythm, dance technique, marching, kicks, memory, projection, showmanship, and overall appearance. The girls with the highest scores will be chosen for membership into Las Gatitas. Number will, not limit acceptance into the Las Gatitas. The number of new members varies based on the above criteria. No certain number will be selected and the decision of the judges is final.

e. What to Wear:

For the workshop, each girl must wear appropriate shorts (preferably with tights underneath) or dance pants, shirt, socks, and tennis shoes. For judging, each candidate must wear white shirt, dance shorts, and drill team dance shoes if you were a drill team member last year, and if you are new to the program, you must wear white ked-type shoes. Your hair must be pulled out of your face. Candidates should look their very best. Dress for showmanship.

f. Dates:

Sign up for commitment to tryout will be Jan. 27 – Feb. 7. Tryout workshop will begin Monday, March 3 – Thursday, March 6 from 4:00 – 6:00. Actual tryouts will be Friday, March 7 at 4:15 p.m. Names of the girls who make the team will be notified by a sealed envelope as soon as scores are tabulated. Officers tryouts will begin immediately following the line member tryouts and they will be notified of their position after that.

2. General Information

a. Constitution:

Las Gatitas are governed by a strict district-approved constitution. Drill team members must read it, study it, know it, and adhere to it's every detail.

b. Demerit System:

Las Gatitas employ a demerit system as a means of developing self-discipline in order to maintain efficient team operation. Demerits are given for various minor and major offenses and members can be dismissed from the team upon an accumulation of excessive demerits. Each member is expected to know and understand the demerit system.

c. Absenteeism:

In order to maintain a high standard in our drill team, absenteeism must be kept at a minimum. Jobs must not interfere with practice or performance throughout the course of the year. A drill team member must attend all practices and performances unless she is ill with a doctor or parent's written excuse. When she is ill, if at all possible, she should attend practice to observe. It is the drill team member's responsibility to notify the sponsor if she is unable to attend. **If she misses 2 or more practices during one week, excused or unexcused, she will be ineligible to perform that week.**

d. Academics:

According to TEA/UIIL rules, drill team members must have a 70 average in all subjects at the end of the first six weeks grading period or she will become ineligible to participate for the following three weeks. At the end of the first 9 weeks, the grades will be checked again. At that time if the member is passing **everything**, then she becomes eligible to perform again. An incomplete is a failure till complete. A member must also have no more than one "N" or have a "U" in citizenship during a grading period or she will be ineligible to participate for 3 weeks.

e. Practice:

Las Gatitas attend summer camp at Celina High School for one week during the summer. **Drill team camp is essential and mandatory for the success of the program, and all Las Gatitas members are required to attend.** Practice will be held for the last week of July. Las Gatitas practice everyday after school during regular football season and play offs until approximately 6:00 p.m. Special appearances are all attended. Jobs will not excuse an absence and must not interfere with practices or performances. During play offs there are games that at times fall during the Thanksgiving holidays and sometimes during the Christmas holidays. Members are required to attend the practices that are scheduled and perform in that weeks game. Demerits will be given daily for non-attendance and tardiness.

There are also special pep rallies that occasionally will be held during the season or during playoffs. These pep rallies are our black out pep rallies to promote a special school spirit. Practices for these obviously cannot be held till it is dark. With that being said, the night before that pep rally will require a late practice usually beginning at 7:00 or 8:00 depending on the circumstances and runs till we know that everyone has the performance down. These pep rallies are very confidential to only those participating and to the administration. The purpose of this is for the safety of all those who are participating.

Homecoming is another exception to a late night. It has always been the **TRADITION** of CHS to decorate lockers for the team and the girls sisters. This requires everyone to be here late with helping cheerleaders decorate and doing our locker decorating.

f. Standards and Conduct:

Las Gatitas are an official representative of Celina High School and the Celina I.S.D.; therefore, members are subject to school board policies. Each member must maintain high moral and ethical standards and use good judgment at all times. Conduct must always be lady-like and above reproach. Membership may be terminated for unacceptable standards or conduct.

A member who quits or is terminated will not be eligible for membership in **any** Celina High School spirit-organization for the following year without the written permission of the previous year's sponsor. The spirit organizations include the Cheerleaders and Drill Team.

Las Gatitas mom's and dads are expected to work twice at the concession stand during the Junior High and JV football games. The concession stand proceeds help pay for uniforms, props, and general drill team operating expenses. A sign-up date for this activity will be decided.

This is only a brief outline of the Las Gatitas Drill Team. Reading the Constitution should cover any questions about specific rules and regulations. It is necessary for both you and your daughter to fully understand what would be expected of her should she make Las Gatitas. If either of you do not think you will be able to adhere to the procedures and rules of the Las Gatitas, then she should not try out. The Las Gatitas are a group that are proud of their accomplishments and want to maintain a high standard of performance, academics, and citizenship.

Drill team takes: **Dedication, Discipline, Commitment, and Rigor. The young ladies who make the drill team will have an obligation to uphold the excellence.**

I will do everything possible to make tryouts a beneficial experience for your daughter. Self-discipline, good attendance, and a positive attitude on your daughter's part will help. **Encourage your daughter to stretch every evening, practice when possible, and keep smiling!**

CONSTITUTION

ARTICLE I

Name

The name of this organization shall be the “Las Gattitas” of Celina High School

ARTICLE II

Purpose

The purpose of this organization shall be:

- A. To increase and develop character, scholarship, leadership, individual responsibility and to maintain high moral character.
- B. To promote school spirit and sportsmanship.
- C. To represent Celina Independent School District at the major athletic and school functions, on and off campus.
- D. To encourage and support interest in all sports, fine arts, and other activities at our school.
- E. To create and maintain a very high standard of precision dance to be performed at school functions approved of by the director and administration.

ARTICLE III

Colors

The colors of this organization shall be orange and white.

ARTICLE IV

Motto

Each young lady has the potential for greatness within herself—believe and strive for great results. If drill team were easy, everyone would be a member.

ARTICLE V

Membership

SECTION I – Eligibility for Membership

A. Basis for Selection

Prospective members of the Las Gattitas shall be selected on the basis of their ability to contribute to the good of the group. They will be screened and judged on the basis of high academic and social standards, interest in the organization and performance abilities.

B. Grades

The grade policy governing drill team membership at Celina High School was designed to give as many girls as possible the opportunity to serve their school, while encouraging the maintenance of high academic standards.

Candidates will follow the UIL guidelines. If they have failed a class at the 2nd 9 weeks, they must be passing all classes at the last mid UIL grading period as indicated in the UIL documents. They may not have more than one citizenship grade below the S level at the time of tryouts or as their cumulative citizenship average for the academic year. A citizenship grade of U is equivalent to two N's.

C. Appearance

A young lady must have good personal habits and be neat in appearance.

D. Permission

A permission form will be supplied to each candidate and must be returned properly completed and signed by parents in advance of the tryout date. Each prospective member must have three teacher recommendations in order to be eligible to try out for the team.

E. Prospective Officers

Any young lady who wished to try out for an officer position must have been a member of Las Gattitas the previous football season and must have been a member in good standing. Only sophomores or juniors will be eligible to tryout for line officers. Freshman, sophomores, and juniors are eligible to tryout for social officers.

SECTION II - Tryouts

Each prospective member must try out for Las Gattitas. Tryouts are judged by out-of-town judges and based on ability, projection, coordination, technique, and rhythm.

SECTION III - Maintenance of Membership

A. Grade Requirements

Grades will be checked periodically to affirm that every girl is maintaining the required average to continue performance with the team.

1. Participation is governed by the TEA/UIL Eligibility rule. A member who has less than a 70 average in each class at the end of the six-week grading period for the first six weeks of school will become ineligible for three weeks. At the end of the first 9 weeks, the grades will be checked again. At that time if the member is passing **everything**, then she becomes eligible to perform again. An incomplete is a failure till complete. A member must also have

no more that one "N" in citizenship during a grading period or she will be ineligible to participate for three weeks. At the end of three weeks the member must be passing all classes.

2. An officer must meet the same grade point average requirements.

B. Conduct

Any member who accumulates 5 demerits will not be allowed to perform during the week after the 5th demerit. Upon receiving 10 demerits, a letter will be sent home to the member's parents. Fifteen demerits will require immediate dismissal from the team.

SECTION IV – Loss of Membership

If a member fails to maintain the standards of scholarship, conduct, character and performance required of the members of Las Gatitas, it will demonstrate cause for the young lady's suspension from the group. If she is suspended, she will not participate in any drill team activities for the rest of that drill team season.

The following grounds for immediate suspension govern drill team membership in the Celina Independent School District:

1. Unexcused absence from a required performance without notifying director first.
2. Accumulation of the maximum number of demerits, which is fifteen (15).
3. Any violation of school policy in uniform while representing this organization in an activity.

A member who quits or is terminated from their position is ineligible to participate in any spirit related organization the following year without the written consent of the previous year's sponsor.

SECTION V – Duties and Responsibilities of Membership

A. Attendance

1. All line members shall practice regularly during and after school as dictated by the performance schedule. Every member shall be present whenever required. A member missing two or more practices during a week for any reason will not be allowed to perform that week.
2. Members will arrive on time to practice and stay until dismissed by the director.
3. The only reasons accepted for absence, are illness or death in the immediate family.
4. Drill team camp will be held each summer on designated dates and attendance is MANDATORY.
5. Practice may be required on school holidays or weekends.

6. If we are in playoffs during the holidays members are expected to attend practices and the game.
7. All members parents are required to work the concession stand twice during the season. If a parent does not work, then the member is not allowed to perform at the following game.

SECTION VI – Officers

The Officers of this organization shall consist of the Captain and 2 Lieutenants.

The Officers are to set an example for all to follow, enforce the Constitution, choreograph, teach and polish dances, make sure that all members know the dances, issue demerits, have input into the policies and decision-making, report offenders, be sensitive to the team's needs, promote good relations among team members, among themselves with other organizations, demonstrate initiative and good leadership at all times.

A. Captain

1. The head officer shall uphold all the responsibilities of the lower ranking officers.
2. She has the responsibility of supervision over the other officers and members.
3. She is directly responsible for the team's field commands when in performance.
4. The head officer is second only to the Director and is in command of all drill team functions. She shall work very closely with the Director in making drill team decisions.
5. She is to work with the Director in planning performances, making up routines, teaching routines, and is responsible for helping to perfect over-all performance.
6. She is to meet with the Director and discuss the development and progress of the group.
7. She is responsible for setting an example for other drill team members by maintaining a positive cooperative attitude, for promoting school spirit and drill team unity.

B. Lieutenant

1. The officer second in command is the First Lieutenant, followed by the Second Lieutenant.
2. She is responsible for assisting the head officer with the team's field commands when in performance.
3. She is responsible for maintaining a good relationship with the other officers.

4. In the absence of the Captain, the First Lieutenant assumes the duties of the Captain, then followed by the Second Lieutenant.

All officers will be allowed to give demerits to team members and this will be done regardless of their social affiliation with those members.

ARTICLE VII The Demerit System

SECTION I – Assignment and Record

- A. An accumulation of 15 demerits at any time during the season will be cause for suspension from the organization.
- B. Demerits will be the responsibility of the Director but can be given by the officers if cleared with the Director. The person issuing the demerit must inform the member who receives it and record it on the day of assignment.

SECTION II – Penalties

A member will be benched for being sent to the office depending on the severity of the instance.

Members will receive 1 demerit for any of the following:

- Tardiness to practice
- Leaving practice early
- Failure to turn in fees or materials on time
- Chewing gum at practice
- Unclean uniform, shoes or socks
- Wearing of jewelry in uniform
- Failure to have hair properly fixed
- Talking to outsiders in stands at performances
- Moving from assigned seat in stands

Members will receive 1 1/2 demerits for any of the following:

- Missing practice
- Failure to obey officer commands
- Chewing gum in uniform
- Not being in required clothing on a daily basis while at practices and games
- Failure to cheer with the cheerleaders
- Failure to return props to the dance room after practice or performance
- Leaving items in stands or on bus after performances
- Soiled, torn or incomplete uniform: gloves, pom poms, etc.
- Demonstrating unsportsmanlike conduct
- Arriving at a performance after half-time, excused

Members will receive 2 demerits for each day they are assigned to CDC.

Members will receive 2 demerits for arriving at a performance after half time, unexcused.

Members will receive 3 demerits for cheating on an assignment or exam. A CHS staff member must notify the sponsor.

Members will receive 3 demerits for missing a performance, excused.

Members will receive 4 demerits for missing a performance, unexcused.

Members will receive 15 demerits for breaking any school policy regarding smoking or drinking. Members will receive up to 15 demerits for participating in public acts, which discredit or bring embarrassment to the organization.

Each member will be informed weekly as to the amounts of demerits received. Upon receiving 5 demerits, a member will not be allowed to perform the following week but will attend all practices, meetings, etc.

ARTICLE VIII Las Gatitas Uniform

SECTION I – Performance Uniform

- A. Will consist of any items that are worn for a performance and shall be treated as such.
- B. Additions may be made at any time.
- C. No jewelry shall be worn.
- D. All uniforms must be clean, kept in their garment bag, and in good repair. Hats are to be kept in their hatboxes when not being worn.

SECTION II – Game day uniforms

- A. The Game Day uniform will consist of the outfit chosen by the Officers and Director.
- B. Each member is required to wear this uniform on the designated day.
- C. No jewelry that is distracting or gaudy may be worn with the uniform.

SECTION III – General Appearance

- A. Hair must always be neat. During practice, hair must be out of the face and away from the eyes.
- B. While performing, the hair must be worn as designated.
- C. Make-up worn during the performance will be applied liberally as designated by the Officers with approval of the Director.

SECTION IV – Other Drill Team Items

- A. During the course of the season, each member may be issued additional items to enhance their uniform, add to their performance ability or help the member be more comfortable while performing their spirit duties. Items may include pom poms, blankets, leggings, etc.
- B. Each member is responsible for maintaining these items in good repair and returning them at the proper time in good repair. Any item deemed by the sponsor to not be in good repair will be cleaned, repaired or paid for by the member.

ARTICLE IX Drill Team Appearances

SECTION I – Behavior

- A. The drill team will help promote spirit and acceptable behavior at all athletic and drill team appearances.
- B. When sitting in a group, they will cheer, do all hand routines and stand or sit as directed.
- C. No outsiders may sit with or visit with any member.
- D. There will be no eating in uniform and no drinks until after performance.
- E. Permission to leave will be given only for extreme emergencies such as illness, and then only accompanied by a parent.

SECTION II – Transportation

- A. Bus Transportation will be provided for out of town activities.
- B. All members must ride the bus to and from the activity unless parents, **in person**, acknowledge that that the member will be riding with them.

SECTION III – Inspection

- A. Inspection for proper dress, make-up, jewelry, etc. will be held prior to final practice for any performance.
- B. Every member must meet the requirements of the inspection at the designated time.
- C. Every member must be completely ready at the time of inspection.

ARTICLE X Code of Conduct

The Celina High School Las Gatitas is a dance/drill team composed of fine young ladies, and it is a goal of this organization to conduct themselves as young ladies.

The following rules shall govern the conduct of each member of this organization. It must be understood that each girl is responsible for upholding and seeing that others uphold the Code of Conduct at all times.

It is the purpose of this organization to encourage the maintenance of high standards and ideals as set forth in the event of reporting misconduct to the Director.

Any disciplinary action will be in full accordance with school and district policies, as stated in the CISD Policy and Procedure Manual.

No member of this organization shall:

1. Smoke in public while she is a member of Las Gatitas.
2. Experiment with drugs at any time while she is a member of Las Gatitas.
3. Shall use alcoholic beverages while she is a member of Las Gatitas
4. Any drill team member participating in a public act, which may discredit or bring embarrassment to the school, or organization may be suspended pending review by the CHS principal and sponsor. The Internet is a worldwide, publicly accessible form of communication. Any communication such as MySpace, Facebook, etc. appearing on the Internet is public domain even if it is marked private. Drill Team members are responsible for their personal websites and postings as well as for postings on other students' websites. The area of appropriateness will include but are not limited to, language, pictures, suggestive poses, clothing, reference to alcohol, drugs, and tobacco. Any question of appropriateness will be decided by the principal and sponsor. They should be aware that in or out of uniform, they are held to a higher standard and should act accordingly.

OFFICER REQUIREMENTS

REQUIREMENTS FOR LINE OFFICERS

1. Make up a 1:30 – 2:00 minute routine of your own. It must have kicks, leaps, turns, and splits.
2. You must present a notebook to the judges with typed notes of your routine, a resume about yourself, pictures of yourself, your report card, and 2 letters of recommendation.
3. You must be able to teach 4 – 8 counts of your routine to another member.
4. You must be prepared to learn a short routine the day of tryouts.
5. You must be prepared to do a sequence of kicks, leaps, turns, your splits, etc.

REQUIREMENTS FOR SOCIAL OFFICERS

1. Make up a stand routine from our stand music.
2. You must present a notebook to the judges with typed notes of your stand routine, a picture of yourself, an example of a monthly calendar of activities for the drill team (ex. birthdays and socials), an example of daily devotionals for the squad, and a report card.
3. 2 letters of recommendations.
