The Board Update: State Revenue Forecast & K-12 Advocacy Priorities is intended to provide information and clarification in response to an ask from a board member heading into the 2026 Legislative Session. Statewide education leaders, including COSA, have identified three important messages for districts for upcoming budget conversations: 1) The forecast is positive, but we must remain vigilant. 2) The state is forecasting additional unbudgeted costs. 3) One more key forecast is ahead – and we must be prepared to adjust. The next and final forecast for this biennium will be released on February 4, 2026, and will be used to finalize the budget for the 2026 session. Mrs. Jones
