With the air conditioning work scheduled this summer at Holmes & Irving (auditorium) Schools necessitating associated asbestos abatement work, a legal notice calling for such work was published in the <u>Oak Leaves</u> (see attached) on April 4, 2013, (indicating a mandatory pre-bid meeting on April 10, 2013) along with the list of vendors invited to bid, as well as the bid summary. Three bids were submitted on the due date of April 18, 2013.

Our asbestos consultant, Carnow, Conibear Associates, Ltd., is recommending award to the low bidder, Arc Environmental in the total amount of \$23,500. Recognizing the disparity between the low bid amount and the high (\$49,750), the District requested a scope of work review with Arc Environmental and we have been assured that the "contractor confirmed all work has been included in the bid document submitted" (see attached letter from Carnow, Conibear & Associates, Ltd.).

We are recommending award to Arc Environmental and this item will return to the Board for formal approval at its May 28, 2013 meeting.
