The “Make Education a Priority” Initiative

Dear Superintendents & School Board Presidents of Region XV:

I am sending this as your Region XV Director to the TASB Board, urging you to support the “Make Education a Priority” Initiative. This initiative, begun by the Aledo ISD Board of Trustees, has as its goal to stay focused on the public school finance issue and to ensure that public education is among the highest priorities for the upcoming 82nd Legislature Session.

Since 2006, the implementation of HB1 has led to an increasing number of school districts that face financial crisis. The number of districts forced to adopt a deficit budget grows from year to year. Many more face difficult decisions to reduce teaching positions and staff, cut salaries and benefits, and/or curtail educational or extracurricular programs in order to close budget gaps.

Neither the 2007 nor the 2009 session did much to address the twin issues of adequacy and equity; any improvements in public school finance were incremental. Meanwhile, the need for significant and wholesale change has yet to be addressed and the current economic crisis is compounding fear and concern. Unless school boards across the state join together in conveying a sense of urgency in Austin, school finance will meet the same fate in the 82nd Session.

Quite often, legislative priorities are established in the months and weeks leading up to a session, meaning now is the time to act with a collective and effective voice. With that in mind, our board at Grape Creek ISD joined hands with Aledo ISD in adopting a modified version of the priority resolution. This has been attached for your convenience.

Likewise, our board is asking you to join us in becoming like-minded districts across the region. Let's transform the "Make Education a Priority" initiative into a grassroots movement here in West Texas and then across the State of Texas.

Though we believe that the coming years will be make-or-break for many districts, we have hope that with a unified voice we can effect a sense of urgency and commitment. As you join us this movement, we suggest that you forward your adopted resolution to your respective legislators, as well as the individual chairs of the House and Senate Public Education Committees, the Lieutenant Governor, and the House Speaker.






