OUR PROPOSAL

The talented staff at JTHS works diligently to ensure that all students have the resources necessary to live productive lives. Like all noble efforts, a full team of dedicated individuals with specialized skills is necessary to produce success. We at Involved Inc, NFP have developed programming to support the specific needs of the student body at JTHS. To support students, we propose to implement our Involved SEL Program.

The Program

Involved SEL Program at Pathways is a specialized social and emotional learning curriculum designed to empower Pathways students to improve self-management, increase attendance, and improve academic effort, while simultaneously learning to cope with trauma to obtain emotional wellness. On a daily basis, Involved SEL Program facilitators will strive to help students identify sources of trauma and seek appropriate help. They will create a safe and supportive educational learning environment which is conducive to student emotional wellness. Finally, Involved SEL Program facilitators will provide daily training on social skills and behavior management. A daily focus will be on student self-management, attendance improvement, and academic effort improvement.
