## **Legislative Update:**

Passed Legislation:

SB74, Internet for Schools "An act relating to funding for Internet services for school districts." Governor signed in to law on 3/25/20 – "\* Section 1. AS 14.03.127(a) is amended to read: (a) Each fiscal year, a district in which one or more schools qualify for a discounted rate for Internet services under the federal universal services program is eligible to receive an amount for each school that is equal to the amount needed to bring the applicant's share to 25 [10] megabits of download a second of the Internet services."

# DEED Commissioner Johnson has made several announcements to assist school districts during the COVID-19 Pandemic School Closure:

- The Alaska Performance Scholarship (APS) has waived the requirement for participation in the ACT or SAT tests in order to qualify for the APS.
- The Commissioner has also exercised his statutory authority to issue emergency teaching certificates to those teachers currently in the student teaching phase of their education.
- The Commissioner is also using his authority to issue emergency extensions of teacher certificates.
- DEED is looking into options for waivers on the minimum number of school days required to count as a school year in light of the emergency school closures.
- State testing has been waived for FY20

# **Communications with Community Agencies regarding Emergency Operations Planning Collaboration**

#### SISD Health Liaison:

Andy Cook has agreed to serve as the SISD Health Liaison between the school district and local and state health officials. Andy is responsible for connecting with health officials to identify local hazards, determine what crisis plans exist in the school district and community, and to establish procedures to account for student wellbeing and safety during such a crisis. Andy is working with local health officials to coordinate their pandemic/epidemic plans with that of the school district.

#### **Communication with Families:**

Regular updates are posted on SISD Facebook page as well as SISD Website. All lead teachers/principals have been asked to also forward families and post in multiple locations throughout the community.

#### **Food Services:**

The delivery of food services for both breakfast and lunch has continued throughout the closure. Schools post their pickup/delivery schedule on their Facebook Page as well as in their community. SISD website lists this process for each school.

#### **Instruction Delivery:**

The delivery of academic instruction via distance has continued throughout the closure. Plans have been made by all teachers to address the continued academic needs of their students through May 1, 2020. Instruction delivery methods vary depending on the needs of individual students (internet, phone, paper packets with books, supplies, etc.) Schools post their academic pick up/delivery schedule on their Facebook Page as well as in their community. SISD website lists this process for each school.

#### **School Closure Update:**

Current information shows that there will be a total of four (4) students living in Hyder during 2020-21 school year. Correspondence school services will be provided for these students via the Hyder library. Other students will be living in and attending school in Stewart, BC which is approximately 3 kilometers from Hyder.

## 2020-21 Certificated Staffing

A Special Education Coordinator position has been created and this position will be covering the following duties: Special Education, 504, Gifted and Talented Student Services, Intensive Special Education Center-Based Program Coordinator, Special Education Substitute Teacher, District Testing Coordinator, Correspondence and Home School Programs Coordinator, etc.

The Assistant Superintendent/Area Principal will be the site administrator for all school sites district wide. This position will also oversee Student Activities, Food Services, and Transportation.

The Thorne Bay School will have one less high school teacher; however, the newly-hired Assistant Principal will be teaching 1-2 high school courses, one of our elementary teachers may be teaching one high school course, and some of our high school courses will be covered by distance as they are in smaller sites.

# **Collective Bargaining Agreement:**

The Negotiations Committee will be meeting on 3/30 and 4/8 to discuss proposed changes from the negotiations that have taken place so far as well as additional negotiations regarding salary and benefits.
