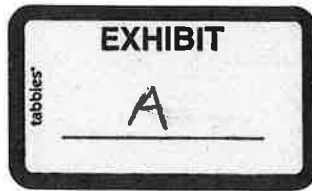

Parcel B

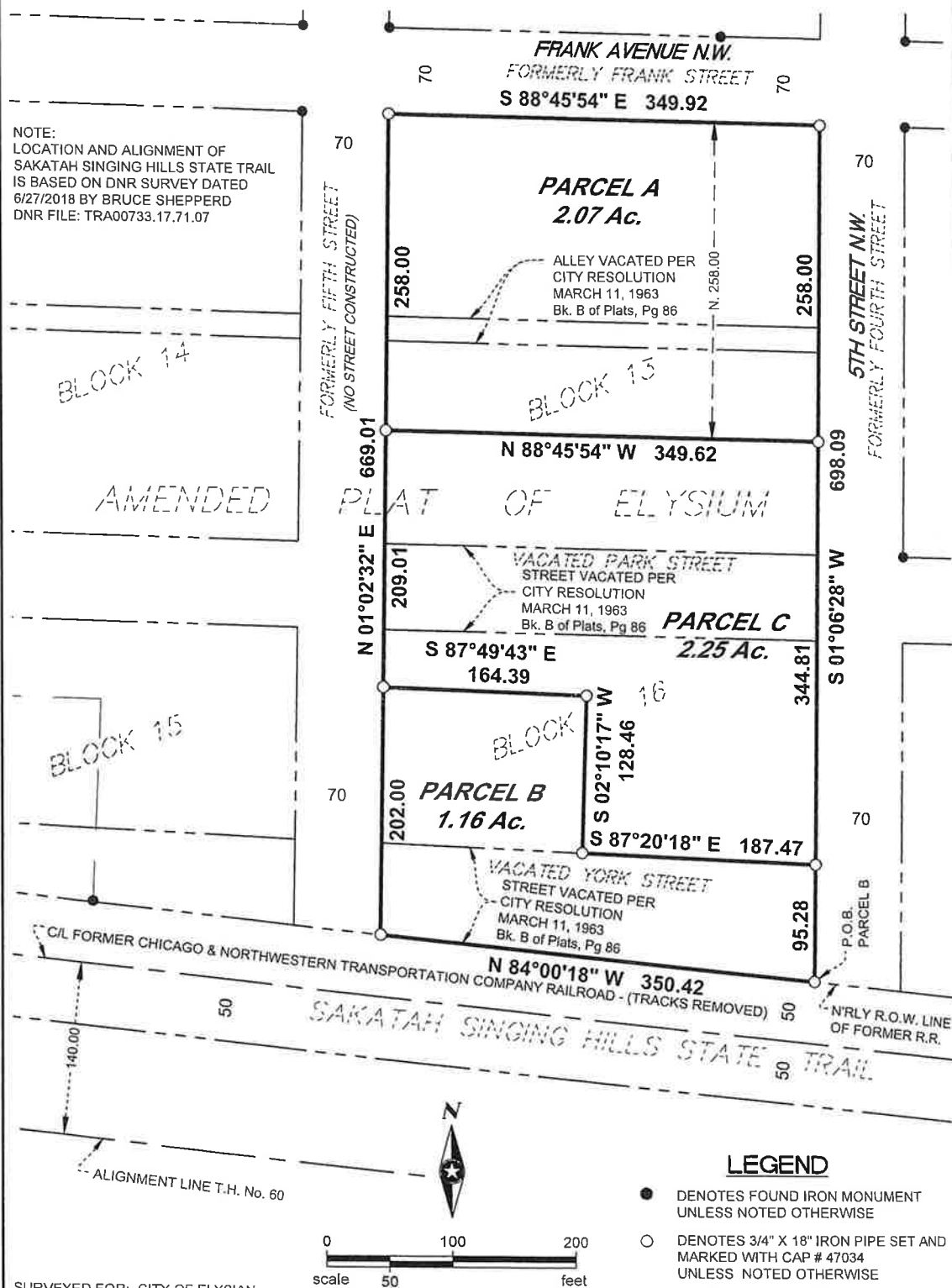
