PUBLIC COMMENT

I am asking that the district takes at least one day each year to educate students on gender identity and sexual orientation.

My name is Hannah Gordon. I am a student who graduated 8th grade this year and I noticed that during my time at Beye and Julian there was a significant lack of education on LGBTQIA+ themes and identities.

Many students in our district have a very limited knowledge of these concepts despite the number of kids who identify under LGBTQIA+ labels. I may have educated myself on these topics, but not every student will go out of their way to do that.

Kids, especially middle school kids, need to know what it means to be gay, or trans, or ace, because they need to know what they're going through. Kids who are LGBTQ may not identify with their birth sex or not experience attraction the way that their peers or adults tell them is "normal." They end up confused as to what is "wrong" with them. This can cause a whole ton of other issues with mental health. Imagine a trans boy wondering why their body feels wrong, why they don't fit in, and why they feel completely alienated in their own skin. Or a bisexual kid who can't figure out why their sexuality is "broken" and they like both girls and boys. The best way to solve this issue is education. Education on this topic will help

prevent homophobia and transphobia in the next generation of students, since hate tends to stem from misunderstanding and lack of education.

All I ask is that the district takes one day a year, minimum, to educate students on LGBTQ+ identities so that they can know that what they or their peers are going through has a name and that they aren't alone. The best case scenario that I would really love to see is an LGBTQ+ unit added to the health class curriculum at our middle schools. This curriculum would need to teach about these topics: gender identity and sexual orientation. A person's identity is such a huge part of them. To not be educated on that is completely unacceptable, in my opinion. I strongly believe that this needs to change.
