# Minutes of the May 19, 2008 Regular School Board Meeting

#### **NEW BUSINESS**

President Gautille presented the results of the May 10, 2008 school board election (attached).

After canvassing the election results, President Gautille certified the election and declared Thom Hulme winner in Place 4, and Scott Orr winner in Place 5.

Anthony Hill made a motion to approve the Order Declaring Results of Trustee Election. Bennett Ratliff seconded the motion. The motion carried 7-0.

Kay Ryon, Board Assistant Secretary, administered the Officer's Statement and Oath of Office to the newly elected Board members: Thom Hulme (Place 4) and Scott Orr (Place 5).

Vice President Bennett Ratliff conducted the election of Board Officers.

Scott Orr made a motion to elect Cindy Warner to the office of President to the Board of Trustees. Anthony Hill seconded the motion. The motion carried 7-0.

David Apple made a motion to elect Bennett Ratliff to the office of Vice-President of the Board of Trustees. Cindy Warner seconded the motion. The motion carried 7-0.

Anthony Hill made a motion to elect Susie Kemp to the office of Secretary of the Board of Trustees. Scott Orr seconded the motion. The motion carried 7-0.

#### **AWARDS**

Todd Kettler, Director of Advanced Academics, recognized **Jenna Adkinson**. Jenna is a senior at Coppell High School and a dual credit student. She has earned an associate's degree while attending CHS.

**Tammy Gilstrap** was recognized for coordinating the school district's participation in Oprah's Big Give Peanut Butter Drive last month. Through her efforts, the district donated more than 9,870 jars of peanut butter to the North Texas Food Bank.

Students from the **EXCITE 2 Sophomore Engineering Class** at CHS and their teacher, **Mike Yakubovsky**, were honored. The students competed in the Texas Marine Advanced Technology Engineering Underwater ROV competition in April at NASA's Sonny Carter Neutral Buoyancy Lab in Houston and took first place in the poster portion of the competition.

#### **BOARD REPORTS**

Board President - Cindy Warner gave reports on the Coppell Nature Park and the Education Foundation Banquet. She also recognized Board Member Anthony Hill for receiving the Career & Technology Association of Texas (CTAT) Community Service Award for Area 2 (an eleven county group).

Anthony Hill reported on the Districtwide Educational Improvement Council held on May 8<sup>th</sup>, the North Texas Area Association of School Boards meeting that took place on April 16<sup>th</sup>, and IBM eWeek (February 17-23).

Bennett Ratliff stated that the PIN (Parent Information Network) met. In order to better define the purpose of the group, the name has been changed to Special Education Advocacy Committee (SEAC).

## **CISD HEART RESCUE PROGRAM**

Debra Hart, Director of Student Services, reported that CISD was awarded a grant from the Medtronic Foundation's "Heart Rescue Program" in the amount of \$9,600.00 to implement the "CISD Heart Rescue Program" to provide comprehensive training for target CISD staff who will then teach students about sudden cardiac arrest and the use of CPR/EADs.

Scott Orr made a motion to amend Board Policy EIF (LOCAL) to reflect adoption of graduation criteria for graduates of New Tech High @ Coppell as presented. Anthony Hill seconded the motion. The motion carried 7-0.

Susie Kemp made a motion to change Board policy to award Technology Application graduation credit in Career and Technology Programs of Study that meet the guidelines outlined in TAC Chapter 74, Subchapter F, 10, D as presented. Bennett Ratliff seconded the motion. The motion carried 7-0.

Bennett Ratliff made a motion to submit a proposed advocacy resolution to the Texas Association of School Boards to support requiring cities to notify local school districts when proposed zoning changes may affect residential development and/or development density. Anthony Hill seconded the motion. The motion carried 7-0.

SHW presented a conceptual plan for school buildings in the North Lake development area. Bennett Ratliff made a motion to approve the conceptual plan as presented and authorize the administration to continue to refine the plan as more information becomes available over time with one immediate refinement that the stand alone elementary site is to be within the boundaries of the property being acquired. Anthony Hill seconded the motion. The motion carried 7-0.

At 9:43 p.m. President Warner declared the Board in Closed Session as authorized under the Government Code of Texas, as allowed by Section 551.074 (personnel matters).

At 10:22 p.m. President Warner declared the Board in Open Session.

Thom Hulme made a motion to accept resignations for CISD professional personnel as recommended by the Superintendent. Anthony Hill seconded the motion. The motion carried 7-0.

David Apple made a motion to employ professional personnel, subject to assignment, as recommended by the Superintendent. Thom Hulme seconded the motion. The motion carried 7-0.

Anthony Hill made a motion to approve the renewal of CISD professional contracts as recommended by the Superintendent. Thom Hulme seconded the motion. The motion carried 7-0.

Susie Kemp made a motion to appoint Kay Ryon as Assistant Secretary to the Board. Anthony Hill seconded the motion. The motion carried 7-0.
