Senate Bill 66

• Is 'an act relating to the use of epinephrine auto injectors on public school and open-enrollment charter school campuses and at or in transit to or from off-campus school events.'

Training

- Each school that adopts a policy is responsible for training school personnel in the administration of epinephrine auto injectors.
 Training must include:
 - 1) signs and symptoms of anaphylaxis
 - 2) administration of epinephrine auto-injectors
 - 3) implementing emergency procedures
 - 4) proper disposal of used auto-injectors

- Training must be provided in a formal session or through online education
- Must be completed annually

• The district or school must provide written notice to a parent or guardian of each student enrolled in the school district. This notice must be provided before the policy is implemented by the district or school and before the start of each school year.

 Will the district train and authorize volunteers to administer an epi-pen?

• 2. Will the district authorize its trained personnel to administer epi-pens only on a school campus?

-RN Epipen Committee recommends authorizing trained personnel to administer epipens on a school campus during instructional hours and in transit to and from district authorized activities.

• 3. Will the district narrowly define "all hours the campus is open" as the instructional day or extend to before/after school?

-RN Epipen Committee recommends that the hours be defined as "during instructional time only".
