Description:	On May 31, 2023 the Texas Education Agency (TEA) released the adopted Texas Administrative Code Rules Concerning School Facilities. One of the new requirements states that at minimum all perimeter fencing needs to be 6' non- scalable or 8' chain link fence.
	On August 21, 2024, the Board of Trustees approved the competitive sealed proposal as the construction method. The District issued CSP 2024-05 on October 16, 2024 and closed the bids on November 14, 2024.
	The district has been awarded an allotment for the SAFE (Safety and Facilities Enhancement Grant) in the amount of \$5,627,213. Please find enclosed the pricing submitted by the vendors to achieve this district wide.
