Background Information

RWHS Fire Update	Alan Gaylor, the Director of Buildings and Grounds, will provide an update about the fire and clean-up in RWHS.
Republican Eagle Column about Energy Program	A recent column in the Republican Eagle highlighted the energy program in RWPS. Either Alan Gaylor and/or Kevin Johnson will be present to answer questions.
Transportation for Charter School	The attached MDE memorandum provides information about transportation for the charter school. The district's reimbursement rate for 2022-23 will be about \$310/pupil. There are concerns about dropping-off and picking-up at the charter school because it has a one-lane road in/out. This could delay bussing by 5-10 minutes. Superintendent Anderson shared concerns with the City.
MCA Testing on April 6 th	Jess Pena finalized plans to distribute food to 9 th – 12 th graders due to distance learning on April 6 th . George Nemanich shared the plan with parents and school board members. Mr. Nemanich also assigned employees particular tasks for April 6 th .
