

**Frisco ISD Cooperative Interlocal Fees and Disposition Report
2024-2025**

Background Information:

- Participation in interlocal agreements for purchasing cooperatives is authorized by Section 791 of the Texas Government Code. Purchasing cooperatives are intended to increase efficiency and effectiveness of local governments by authorizing them to contract with one another and with agencies of the state. State and national cooperatives offer quality, legal procurement and contract solutions to meet purchasing requirements so an entity can act immediately to access the contracts and services needed. These contracts provide the district the ability to compare costs of products and services that might not otherwise be available. The use of these programs provides efficiency and cost savings for the district.
- Cooperatives allow the district to purchase items at a discounted rate. Pricing is structured for the benefit of multiple government entities with the expectation of large orders spread across many districts.
- State statute (TEC 44.0331) requires that the district provide an annual report on purchasing cooperative contract-related fees, including any management fees, and the purpose of each fee under the contract. The amount, purpose, and disposition of those fees must be presented in a written report and submitted annually in an open meeting of the board of trustees of the school district.

Administrative Consideration:

- Annual fees and rebates for the fiscal year ended June 30, 2025, are listed on the attached Annual Report. The disposition of the fees paid was to the respective purchasing cooperative. The rebates were credited back to the district.
- All Fisd Management Paid Fees were fees paid to interlocal as membership renewals.
