**V.1. 2025 Arkansas History Teacher of the Year-Elizabeth Prewett**

Item V. 1. was presented by Dr. Kiffany Pride, Assistant Commissioner - Office of Learning Services.

Elizabeth Prewett, a secondary social studies teacher at Mills University High School, has been named 2025 Arkansas History Teacher of the Year.

Ms. Prewett will receive a \$1,000.00 honorarium and a collection of books and educational materials from the Gilder Lehrman Institute of American History.

Elizabeth is one of 53 finalists for the 2025 National History Teacher of the Year Award.

## **Action Agenda**

### **VII.1. Request for Final Approval of the DCTE Rules Governing the Arkansas Adult Diploma Program**

Item VII.1. was presented by Stacy Smith, Deputy Commissioner.

The Division of Career and Technical Education (DCTE) Rules Governing the Arkansas Adult Diploma Program were approved to be released for public comment by the State Board on November 13, 2025. The public comment period began on November 15, 2025, and ended on December 16, 2025. Public comment was received, but no substantive changes were made. The Division requested the State Board's final approval of the rules as amended.

A motion for final approval was made by Lisa Hunter and seconded by Dr. Aaron Abbott. The motion unanimously passed.

### **VII.2. Authorization of Payment Stipends and Expense Reimbursement for Board Members**

Item VII.2. was presented by Courtney Salas-Ford, Chief of Staff.

Arkansas Code § 25-46-902 states that every state board may, by a majority vote of the total membership of the board cast during its first regularly scheduled meeting of each calendar year, authorize expense reimbursement of each board member for performing official board duties. The expense reimbursement shall not exceed the rate established for state employees by state travel regulations.

A motion to approve the authorization of payment of stipends and expense reimbursement for State Board Members was made by Lisa Hunter and seconded by Randy Henderson. The motion unanimously passed.

### **VII.3. Consideration of the Recommendation of the Professional Licensure Standards Board for Case No. 25-223 – Mandy Goodwin**

Item VII.3 was presented by Whitney James, Managing Attorney, and Daniel Shults, Chief Legal Counsel, who advised on procedures. Also present were Attorney Cody Kees of Bequette, Billingsley, and Kees Law Firm and Mandy Goodwin, Educator.

The educator objected to the Ethics Hearing Subcommittee's evidentiary hearing findings and recommendation of September 10, 2025, and requested a review by the State Board.

A motion was made by Leigh Keener that Mandy Goodwin violated Standard 2a and 2b. There was no 2<sup>nd</sup> to the motion, and it failed.

A motion was made by Leigh Keener that Mandy Goodwin violated Code of Ethics Standard 2b. The motion was seconded by David Peacock and failed after a roll call vote of 6 No to 2 Yes.
