Scope of Goods and Services

Est. 8530 – Brummett Field Camera System:

- Wired Technologies will provide and install a camera system for the Brummett Field area.
- Five 104 ° fixed lens cameras will be installed on the press box, providing comprehensive coverage of the surrounding area. The cameras will be connected to an existing POE+ network switch located in the press box.
- A sixth 104 ° fixed lens camera will be installed on the 'red shed' building, providing video coverage of the gate and entrance area. The camera will be connected to a new eight port POE+ network switch installed in the 'red shed' building.
- New category cabling will be installed from the new camera locations to the network switches.
- A 16 channel embedded NVR will be installed at the Jr. High providing video management and recording. The NVR will have 16TB (raw) of video surveillance grade storage installed providing over 30days of high quality video retention. The NVR has extra channels and storage drive bays for future expansion.
- The existing wireless links and school network will be used for connecting the cameras to the NVR. This proposal assumes that the wireless links have adequate and stable bandwidth for video transport from the cameras to the NVR.

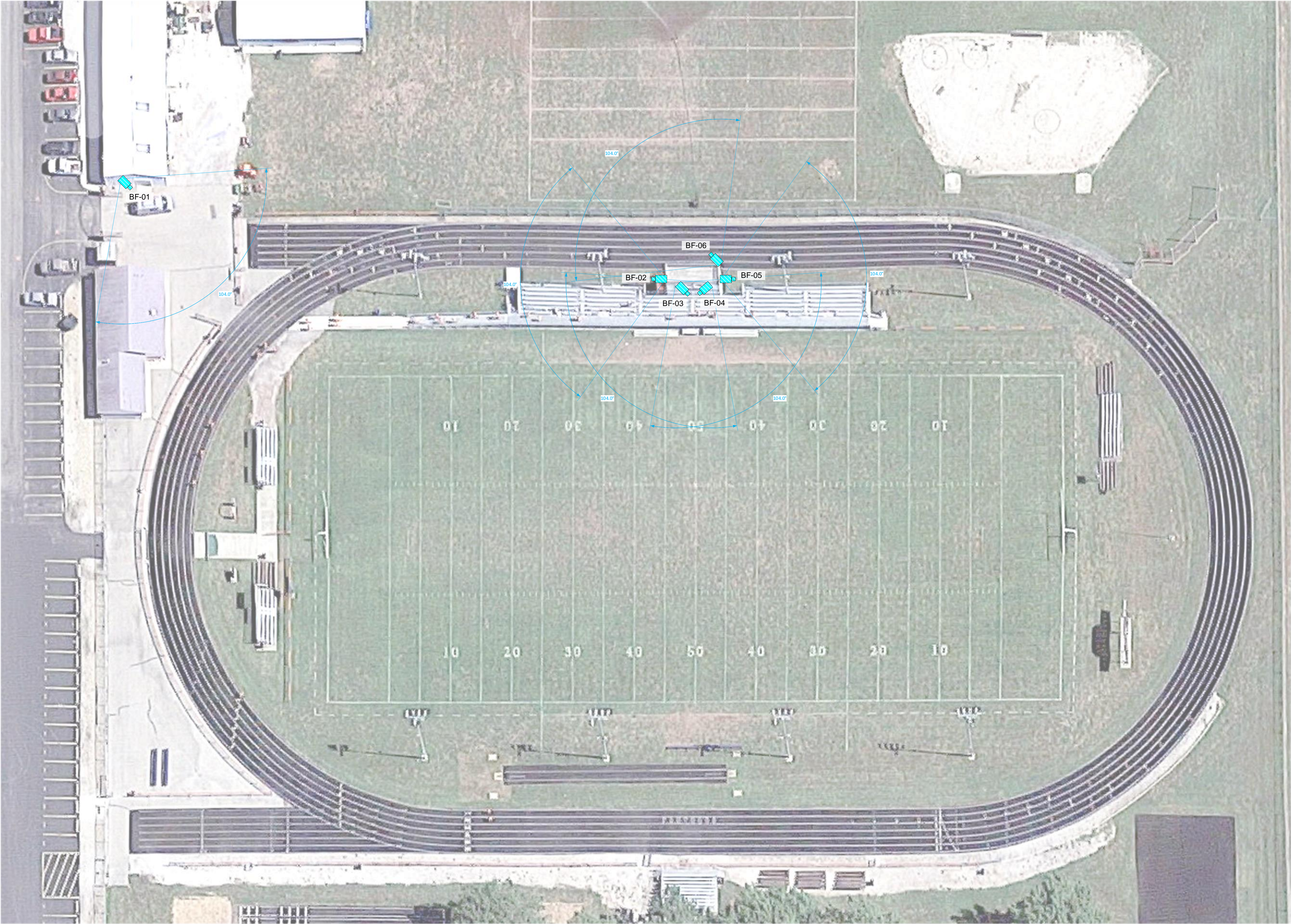
