- Advocacy Resolutions district-submitted stances guiding TASB's response to other issues that might arise before the Legislature and other governmental entities

BACKGROUND INFORMATION:

Resolution proposals will be accepted until 11:59 p.m. on June 15, 2018. Proposed resolutions are first reviewed by the TASB Resolutions Committee and then by the TASB Board. In September, the 2018 Delegate Assembly will adopt approved resolutions that will form part of the 2018-20 Advocacy Agenda, which will remain in effect until the end of the 2020 TASB Delegate Assembly.

As the District continues to express concern and advocates for policy changes to address the capacity of public education to provide an equitable education for all Texas students, we recognize the need for continued support of those organizations supporting our community.
