We are pleased to advise you that the Trustees of Hillcrest Foundation have unanimously approved a grant of \$20,000 to Brackett Independent School District.

Grantee warrants that it is exempt from income tax under Section 501(c)(3) of the Internal Revenue Code and is not a private foundation as described in Section 509(a). Any change in this status shall be communicated to the Foundation immediately. Grantee further warrants that this grant will not result in it becoming a private foundation under the public support test, if such test is applicable to Grantee's organization.
