Mr. Kellen – Reported on multiple items. An additional math club was hosted for tiger club. Two driver ed classes were held and are hoping to hold one more class. Behind the wheel will start soon and larger than usual numbers are expected to participate. Tiger club will be hosted throughout the summer for the first time; thank you Ms. Vagle for organizing this. There were no community ed booklets this past year.

Mr. Carlson – Reported on multiple items. Teacher appreciation week just passed. Three sections will be running for summer school and it is close to being finalized. Track and field day will be held this year. Hoping to have an all school celebration at the end of the year. There will be a kindergarten graduation.

Mr. Babcock – Math and science vacancies have been filled. According to US News and World report Medford ranked in the top 150 schools in Minnesota and in the top 31% of schools nationally. Ms. Goblirsch is a finalist for teacher of the year. FFA did very well and had multiple state participants in poultry contests. Four choir members reached superior status. Business Challenge had Medford teams place 1<sup>st</sup>, 2<sup>nd</sup>, and 3<sup>rd</sup>. Prom went very well. Many restrictions have been lifted for graduation but masks will still be worn. The parade following graduation will be put on again this year. South Central college has received a grant that allows certain high school students to attend college for free.

Mr. Ristau reported on the following:

- I. Enrollment 893 We are at the same enrollment as the beginning of the year but down 18 from this same time last year.
- II. Covid 19 Update Steele County's case numbers are at 30. In district we have 2 quarantining students and 1 positive student. Many restrictions were lifted this past week. Schools are still required to wear masks through the last teacher contract day.
- III. Legislative Update Session ends tonight. They reached a broad budget agreement but without many details. They want to start funding summer school.
