# A RESOLUTION CALLING FOR SUPPLEMENTAL MAINTENANCE & OPERATION LEVY ELECTION

WHEREAS, in accordance with Section 33-802(3), Idaho Code, as amended, the Board of Trustees of School District No. 83, Bonner County, State of Idaho (the "District") has determined there is a need for a Supplemental Maintenance & Operation Levy in the amount of \$2,353,440.60 per year for two (2) years, for the purpose of paying all lawful expenses of maintaining and operating the District, as further described in the form of ballot question set forth in SECTION 3 herein, for the fiscal years beginning July 1, 2025, and ending June 30, 2027.

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of the District as follows:

- SECTION 1. That a Supplemental Maintenance & Operation Levy election be and the same is hereby called to be held in the District on Tuesday, May 20, 2025, for the purpose of submitting to the qualified electors of the District the question set out in the form of the ballot appearing in SECTION 3 hereof.
- SECTION 2. That the Clerk of Bonner County, Idaho (the "County Clerk") shall administer and coordinate the election pursuant to and in accordance with Title 34, Idaho Code.
- SECTION 3. That the form of the official ballot will be substantially as follows:

The estimated average annual cost to the taxpayer on the proposed levy is a tax of \$43.41 per \$100,000 of taxable assessed value, per year, based on current conditions.

Said election will be conducted pursuant to Title 34, Idaho Code.

- SECTION 5. The Clerk shall submit these forms to the County Clerk on or prior to March 31, 2025.
- SECTION 6. That the County Commissioners of Bonner County, Idaho, shall act as the canvassing board pursuant to and in accordance with Title 34, Idaho Code, and will certify and convey the results to the Board of Trustees of the District as provided therein.
- SECTION 7. That if at the election a simple majority of the qualified registered electors of the District authorize such levy, the Supplemental Maintenance & Operation Levy shall be approved and become effective in accordance with the provisions of Section 33-802, Idaho Code.
