SUBJECT: State Mandated 2015 Racial Profiling Report

The attached Racial Profiling Report is mandated by the State of Texas. Each year the police department of every political subdivision of the State must submit this report to their governing body and the statistics included in the report must be submitted to the Texas Commission on Law Enforcement (TCOLE).

Because Collin College police vehicles are equipped with in-car video systems to document traffic stops conducted by Collin College police officers, the Collin College police department is only required to submit the Tier 1 statistical report to the TCOLE. Without this means of documenting traffic stops, the Department would be required to prepare and submit the more complicated and time consuming Tier 2 report.

The data included in the attached report is for 2015 and reflects that Collin College police officers make traffic stops and initiate citation closely proportionate to the demographics of the students attending the College. This indicates that Collin College police officers do not practice racial profiling.

A copy of the Tier 1 Report submitted to TCOLE is attached to this report for reference.

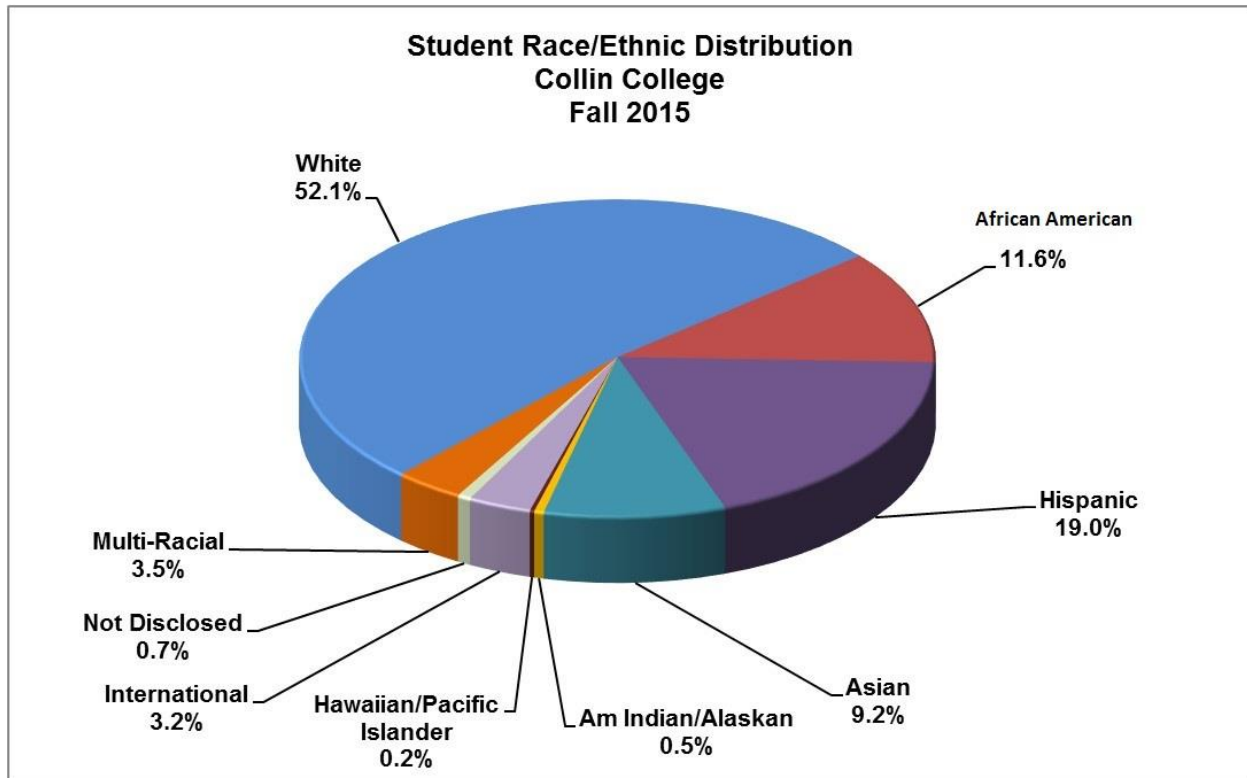
## 2015 Racial Profiling Report

This document encompasses traffic stops gathered during 2015 starting on 01/01/2015 ending on 12/31/2015. During this statistical gathering period it was determined that the Collin College Police Department affected a total of 386 verifiable traffic stops. These traffic stops were categorized by race and ethnicity as set forth by the Texas Commission on Law Enforcement and compared to the student race/ethnicity chart provided for distribution for 2015

**The Collin College Police Department is committed to providing law enforcement services to the community with due regard for the racial, cultural or other differences of those served. It is the policy of this department to provide law enforcement services and to enforce the law equally, fairly and without discrimination toward any individual or group.**

**Race, ethnicity or nationality, religion, sex, sexual orientation, economic status, age, cultural group, disability or affiliation with any other similar identifiable group shall not be used as the basis for providing differing levels of law enforcement service or the enforcement of the law (Tex. Code of Crim. Pro., art. 2.131).**

Below is the required racial profiling statistic as required by the *Texas Commission on Law Enforcement*.

386 Total traffic stops were made.

54 Total traffic citations were issued.

**African American:** 57 Traffic Stops making up a total of **14.76%** of all stops. 9 Citations were issued making up **16.6%** of citations.

**Hispanic:** 45 Traffic Stops making up a total of 11.67% of all stops. 4 Citations issued making up 7.7% of all citations.

**White:** 221 Traffic Stops making up a total of 57.25% of all stops. 34 Citation issued making up 62.9% of all citations.

**Middle Eastern\*:** 25 Traffic Stops making up a total of 6.47% of all stops. 2 Citation issued making up 3.7% of all citations.

**Asian:** 38 Traffic Stops making up a total of 9.84% of all stops. 5 Citations were issued making up a total of 9.25% of all citations.

**Native Americans:** 0 Traffic Stops totaling 0% of all stops. 0 Citations were issued making up a total of 0% of all stops.
