

Each session will be provided by a tutor participating in the Stride Tutoring platform. Sessions can range from 1 student per session to up to 5 students per session. 30-minute sessions are prorated at 50% of the 60-minute session price listed.

Users

Eligible Students (defined below) of Customer will be able to connect with and receive tutoring services from tutors on various school subjects using the Stride Tutoring website at https://stridetutoring.com, subject to availability of tutors. FuelEd will set up the online accounts on behalf of Eligible Students based on information provided by Customer. If requested by Customer, FuelEd will set up online accounts for authorized teachers with scheduling permissions to schedule tutoring sessions on behalf of Eligible Students. Eligible Students will be able to book sessions directly or through an authorized teacher on the Eligible Student's behalf. Customer agrees that FuelEd has the sole right but not the obligation to suspend access of any Eligible Student or teacher to Stride Tutoring if such person, in FuelEd's determination has acted contrary to the Terms of Use published at https://stridetutoring.com/termsofuse, privacy policy, and any other related terms and conditions and policies, pertaining to the use of services, courseware, web sites, platform, and learning management systems, as such terms are set forth therein.

Customer Obligations:

Customer will provide FuelEd with an initial list of students eligible to participate in the Stride Tutoring Sessions (the "Eligible Students") and any information requested by FuelEd that it needs to set up the online accounts for Eligible Students. Customer will provide FuelEd with an initial list of teachers (and email addresses) that are authorized to assign and manage Eligible Students' participation in the Stride Tutoring Sessions. Customer will timely notify FuelEd of any changes to the list of authorized teachers. FuelEd will rely on the list of teachers provided by the Customer. There are no credits or refunds for Eligible Students using the Stride Tutoring platform assigned by teachers if Customer did not provide written notice to FuelEd at least 12 hours before a scheduled tutoring session that the teacher was no longer authorized to assign Eligible Students.

Additional Tutoring Sessions:

During the Period, the Customer may request Stride Tutoring Sessions in addition to those ordered hereunder, subject to availability. The Fees for additional Stride Tutoring Sessions ordered during the Period are set forth in Section 3 of the Order. Customer will be invoiced for such additional Stride Tutoring Sessions upon execution of a new order. Additional Stride Tutoring Sessions must be purchased in minimum increments of \$25,000.00

Session Cancellation:

Scheduled tutoring sessions must be canceled and/or individual students withdrawn from scheduled group tutoring sessions with at least 12 hours' advance notice directly in the Stride Tutoring platform. For group sessions where one or more students are withdrawn from the session ahead of the 12 hours' advance notice deadline, the group session pricing will be adjusted based on the actual number of remaining students scheduled for that session. Scheduled tutoring sessions cancelled with less than 12 hours' advance notice will be subject to a cancellation fee equal to the full price of the scheduled session. For group sessions where one or more students are withdrawn from the session with less than 12 hours' advance notice, but the session is provided to remaining students, the session fee will be the full price of the originally scheduled session with the original number of scheduled students.

Tutor Certifications:

Customer understands that the tutoring sessions made available on the Stride Tutoring platform will be provided by a teacher who is state-certified but may not be certified by the State in which the Customer is located. The Customer hereby represents to FuelEd that State law authorizes such out-of-state licensed teachers for these online tutoring sessions or that the Customer has received a waiver from the State to allow such tutoring sessions by tutors offering tutoring services to students via the Stride Tutoring website/platform. Tutors may, in FuelEd's sole discretion, be either employees or independent contractors of FuelEd or its Affiliates. The Customer represents that FuelEd may rely on these statements.

User Data:

If after expiration of the Order there is a remaining balance, Customer has the option, within 90-days following the expiration of the Order (the "Grace Period"), to either (i) use the remaining balance within the Grace Period or (ii) apply the remaining balance as a credit to a new order, subject to availability. Customer must notify FuelEd in writing of which credit option it intends to use prior to the expiration of the Order. Except for the credit option provided herein, Customer is not entitled to any further refunds, credits or cancellations. Customer will not be entitled to any credit or refund of any remaining balance after the Grace Period. 
