

**RESOLUTION AND ORDER OF THE BOARD OF  
TRUSTEES OF THE FRISCO INDEPENDENT SCHOOL  
DISTRICT CANVASSING THE RETURNS AND  
DECLARING THE RESULTS OF THE GENERAL  
ELECTION HELD MAY 3, 2025, FOR THE PURPOSE OF  
ELECTING MEMBERS OF THE BOARD OF TRUSTEES OF  
THE FRISCO INDEPENDENT SCHOOL DISTRICT FOR  
PLACES 1, 2 AND 3**

On this 12<sup>th</sup> day of May 2025, the Board of Trustees of the Frisco Independent School District convened a public meeting for which notice has been posted in accordance with the Texas Open Meetings Act, Texas Government Code Chapter 551, with sufficient members present to constitute a quorum, and among other proceedings had by said Board of Trustees were the following:

**WHEREAS**, the Board of Trustees (the “Board”) of the Frisco Independent School District (the “District”) duly called and ordered an election to be held on May 3, 2025 (the “Election”) for the purpose of electing a Board Trustee for Places 1, 2 and 3;

**WHEREAS**, the Board has investigated all matters pertaining to the Election, including the ordering, giving notice, appointing officers, and holding and making returns of the Election; the officers who were elected to hold the Election have duly made returns of the results thereof; and said returns have been duly delivered to the Board for official canvassing and declaration of the results of the Election; and

**WHEREAS**, upon consideration of the returns of the Election, it appears the Election was held in accordance with the authorized proceedings and was in all respects legally held after proper notice has been given and said returns were duly and legally made, showing the results contained in Exhibit A hereto.

**NOW, THEREFORE, BE IT RESOLVED AND ORDERED BY THE BOARD OF TRUSTEES OF THE FRISCO INDEPENDENT SCHOOL DISTRICT THAT:**

**Section 1:** The above and foregoing recitals are true and correct and are incorporated into the body of this Resolution and Order.

**Section 2:** It is determined that the results of the Election as canvassed and tabulated reflect the expressed desires of the residents and qualified voters of the District.

**Section 3:** As a result of the canvass, the Board hereby finds and determines that a total of 18,318 votes were cast in the Election for a Board Trustee for Place 1 and 19,143 votes were cast in the Election for a Board Trustee for Place 2 and 19,391 votes were cast in the Election for a Board Trustee for Place 3. Of the votes cast for a Trustee for Place 1, 4,604 of votes were cast for candidate Amit Kalra making up 25.13% of the vote, 7,349 of votes were cast

for candidate Suresh Manduva making up 40.12% of the vote, and 6,365 of votes were cast for candidate Muniraj Janagarajan making up 34.75% of the vote. Of the votes cast for a Trustee for Place 2, 8,343 of votes were cast for candidate Melanie Barrios-Jones making up 43.58% of the vote, 1,577 of votes were cast for candidate Ange Yao making up 8.24% of the vote, and 9,223 of votes were cast for candidate Renee Sample, making up 48.18% of the vote. Of the votes cast for a Trustee for Place 3, 8,965 of votes were cast for candidate Stuart Shulman making up 46.23% of the vote, and 10,426 of votes were cast for candidate Stephanie Elad, making up 53.76% of the vote.

**Section 4:** Based on the results of the Election, the Board hereby finds, determines, and declares the following to be the official results of the Election, and the following named candidates to be duly elected in the Election to the respective named office of the Frisco Independent School District Board of Trustees:

Suresh Manduva, Trustee, Place 1  
Renee Sample, Trustee, Place 2  
Stephanie Elad, Trustee, Place 3
