- Customer provide materials or existing components will not be warranted or operation guaranteed by ACI unless listed in this proposal or prior agreement has been made with ACI representative, as ACI cannot guarantee the condition or reliability.
- ACI not responsible for condition of gates/doors, gate/door frames, closers or any other gate/door devices that ACI did not provide. All MUST be in proper alignment and good working condition for ACI security device associated with gate/door, gate/door frames to function properly.
- Proposed is based on installation to occur during business hours. No after hours or overtime hours are included in this proposal.

- E. Standard 1-year warranty applies to equipment supplied by Advanced Connections, Inc.
- F. Standard 1-year warranty applies to labor supplied by Advanced Connections, Inc.
