- Molly Papillon admissions will add to the "interest survey" for electives the CTE- Health Occupations
 as a choice for incoming, current, and future students. (in order to designate proper resources
 needed for upcoming year)
- Emily Stull Richardson reports that Edgenuity already offers many class offerings to support health careers jumpstart; one addition that will be needed is addition of Certified Nursing Assistant (CNA) which is in Edgenuity; but there is a fee associated with adding that as an option. Will report the fee structure and proposed budget in the May 2021 Board Meeting. (Per Cinda)
- CCS Online Programs would like to prioritize Career Development and Work-Based Learning (on the
 job training and job placement) in the coming year, as Health Occupations is piloted; with the intent
 of shared learnings for the development of the following career-based offerings:
 - Construction Trades
 - o Family and Consumer Science
- This new program will need "Program Approval" through the state. Holly and Cassie will be leading the efforts to work on program approval See details below:

<u>CTE Program Approval</u> – This is a process that districts must complete for all CTE programs if they want ability to access Perkins V consortium funds. Minnesota Rules, Chapter 3505.2500. FIVE main things you need to get approval:

- 1. Licensed Teacher (For the "Pilot" year, Cassie will work with Holly/Emily to get a special Tier 3 CTE License).
- 2. Advisory Board (50% Business and Trade) Cassie will recruit and organize the Advisory Board to include the following: (4 Community Business and Trade and 4 CCS Representatives)
 - a. Golden Horizons Crosslake Director of Nursing or Executive Director
 - b. Whitefish Tealwood Crosslake Director of Nursing or Executive Director
 - c. Senior Class Community in Pequot Lakes Owner/Operator
 - d. Tentative Crosslake Clinic nursing staff member
 - e. CCS Seat Based Administrator (Must sign off on approval of launching the program)
 - f. CCS Online Representative
 - g. CCS Director of Nursing and Health Services
 - h. Possible Board Member?
- 3. Student Leadership Component Health Occupations Students of America (HOSA), or student led blood drive, etc.; Director of Nursing & Health Services will lead this initiative during the pilot stage.
- 4. Series of course offerings (must have a minimum of 2) currently listed in Edgenuity as offerings to choose from:
 - **a. First Aid/CPR** for the following populations:
 - i. Seat based 7th and 8th graders within Health class as an online learning module per Lisa Schumacher; includes a in-person test out and certification for students and any staff who don't have it completed.
 - i. Online Health Education class (all grades); same offering as above.
 - b. Introduction to Health Careers
 - c. Medical Terminology
 - d. Health Safety & Ethics
 - e. Public Health
 - **f. Certified Nursing Assistant** (Need to enhance partnership with Central Lakes College for lab space and testing out those who will be certified for skills)

- Making updates to an existing program.
- A Carl D. Perkins consortia region that is up for five-year renewal.
