IA – REVISED Sept 2009 and Oct 2013 (V1)	Instructional Goals (TRSD adopted in June 2006)	RECOMMENDED. HB 2693 adds language pertaining to “supporting the physical and cognitive growth and development of students”, HB 2362 adds in proficiency requirements. Reference to CIM removed. Clarifies district requirements to use valid and reliable data in evaluating program success. Committee Decision: Revise as per OSBA
IGAEC – NEW Nov 2008	Anabolic Steroids and Performance Enhancing Substances	OPTIONAL. ORS 342.726 and OAR 581-022-0416 require districts to include information and instruction on steroids and performance enhancing substances. Addition of the policy is optional but districts must comply with the requirements. Committee Decision: Adopt as per OSBA
IGAI – REVISED Sept 2009 and Jan 2013	Human Sexuality, AIDS/HIV, STDs, Health Education (TRSD adopted in June 2006 and readopted in June 2008)	RECOMMENDED. Changes are the result of revisions to OAR 581-022-1440. Potential name change to the policy. Committee Decision: Retain clarifying language as per 2008 policy in #6, #13 and #22. Otherwise revise as per OSBA
IGBBA – NEW Dec 2009	Identification of Talented and Gifted	REQUIRED. Clarifies requirements for identification of TAG students. Committee Decision: Adopt as per OSBA
IGBBC – REVISED Dec 2009	Programs and Services – Talented and Gifted (TRSD adopted in June 2006)	RECOMMENDED. Clarifies TAG services must be beyond instruction normally offered, adds in additional TAG service options, and adds in rights of appeal. Committee Decision: Revise as per OSBA
IGBHE – REVISED Sept 2011	Expanded Options Program (TRSD adopted in May 2008)	RECOMMENDED. Corrects the omission that students who have not received their diploma but have met graduation requirements are eligible to participate in Expanded Options and to clarify that at risk students (defined as a student eligible for free/reduced lunch or who meets certain poverty thresholds) have priority. Committee Decision: Revise as per OSBA
IGBHE-AR1 – REVISED Sept 2011	Expanded Options Notification (TRSD adopted in May 2008)	OPTIONAL. Same as above. Committee Decision: Revise as per OSBA

IIA – REVISED Feb 2010	Instructional Resources/Instructional Materials (TRSD adopted in July 2006)	RECOMMENDED. No revision necessary. Revision was to a different version. Committee Decision: No revision necessary.
IIA-AR – REVISED Feb 2010	Curriculum Resources/Materials Selection (Instructional Materials Selection) (TRSD adopted July 2006)	RECOMMENDED. Eliminates language pertaining to CIM/CAM. Potential policy name change. Committee Decision: Revise as per OSBA
IIA – AR(2) – REVISED Feb 2010	Complaints Regarding Instructional or Library Materials (Challenge of Instructional Materials)	OPTIONAL. TRSD policy is labelled IIAA-AR(2). Potential name change to policy. Committee Decision: Revise name as per OSBA, add to our existing language, retain our form.
IIBGA – REVISED May 2009	Electronic Communications System (TRSD adopted July 2006)	REQUIRED. The Children’s Internet protections ACT (CIPA) now requires that districts are educating minors about appropriate on line behavior. Committee Decision: Revise as per OSBA
IIBGA – AR – REVISED May 2009	Electronic Communications System (TRSD adopted July 2006)	REQUIRED. See above. Committee Decision: Revise as per OSBA
IJ – REVISED Nov 2008	Student Guidance (Guidance Program/Child Development Specialist Program) (TRSD adopted July 2006)	RECOMMENDED. OAR 581-022-0405 and 581-022-1510 add career education as part of the district’s guidance and counseling program. Clarifies privileged communication between counselor and student. Possible policy name change. Committee Decision: Revise as per OSBA
IJ-AR – REVISED Nov 2008	Student Guidance (Child Development Specialist Program) (TRSD adopted July 2006)	RECOMMENDED. Adds in requirements if a child development specialist is hired in grades K-8. Possible policy name change. Committee Decision: Revise as per OSBA
IK- REVISED Sept 2011 and May 2013	Academic Achievement (TRSD adopted July 2006)	REQUIRED. Changes are a result of HB 2220 from the 2011 legislative session pertaining to reporting processes. Behavior may not be a factor in grading. Committee Decision: Revise as per OSBA
IKA – NEW Sept 2011 and June 2013	Grading System	OPTIONAL. Clarifies how grades are to be issued. Committee Decision: Adopt as per OSBA
IKAB – REVISED June 2013	Reporting to Parents (Student Progress Reports to Parents) (TRSD adopted July 2006)	OPTIONAL. Clarifies reporting processes to parents. Committee Decision: Revise as per OSBA, adjust our existing language to reflect move to semester grading.
IKF – REVISED Feb 2011, Sept 2011, and Oct 2013	Graduation Requirements (TRSD last adopted Mar 2010)	REQUIRED. Clarifies ELL students may take the OAKS math assessment in their native language, requirements for awarding a modified or extended diploma, and participation in graduation ceremonies. Committee Decision: Revise as per OSBA
IKF – AR – REVISED Feb 2011, Sept 2011 (V2), and Oct 2013	Graduation Requirements (TRSD last adopted Mar 2010)	REQUIRED. Details requirements for awarding different diplomas/certificates. Committee Decision: Revise as per OSBA. Dave Valenzuela will add in process for re-aligning credit

		requirements to semester grading system. Discussion indicates a potential desire for language on awarding an Honors Diploma
IKFB – NEW Sept 2009 and Sept 2011	Graduation Exercises	OPTIONAL. Provides guidelines on graduation ceremonies. Committee Decision: Adopt as per OSBA
IKH – NEW May 2009	Credit for Proficiency	OPTIONAL. OAR 581-022-1131 allows for the awarding of credit by non-traditional manners. Committee Decision: Adopt as per OSBA
IL – REVISED Sept 2012	Assessment Program (TRSD adopted July 2006)	RECOMMENDED. Adds to assessment requirements, removes NCLB requirements that no longer exist under the approved waiver. Committee Decision: Revise as per OSBA
IMB – NEW Feb 2012	Student Achievement	OPTIONAL. Provides language to guide school improvement efforts. Committee Decision: Adopt as per OSBA
INDB – REVISED Oct 2013	Flag Displays and Salutes (TRSD adopted July 2006)	OPTIONAL. HB 3014 requires districts to display a US flag and an Oregon flag at all buildings used or under the control of the district as well as display a US flag in every classroom. Committee Decision: Revise as per OSBA
ING – NEW Dec 2010 and Oct 2013	Animals in District Facilities	OPTIONAL. SB 610 provides guidance on animals in district facilities. Committee Decision: Adopt as per OSBA
ING – AR – NEW Feb 2010, Dec 2010 and Oct 2013	Animals in District Facilities	OPTIONAL. SB 610 provides guidance on what can be asked regarding an assistance animal. Committee Decision: Adopt as per OSBA
