## **Dog License**

You **MUST** submit a copy of your **Rabies Certificate** signed by the veterinarian and **proof** of spay or neuter.

A **1 year** license expires **12 months** from the month of Rabies Vaccination.

A **3 year** license expires **36 months** from the month of Rabies Vaccination.

If rabies vaccination is kept current and rabies vaccination does not lapse:

**1 year dog license:**

- Unsexed: \$10.50
- Sexed (Male or Female):  
\$16.50

**3 Year (where eligible):**

- Unsexed: \$27.00
- Sexed (Male or Female):  
\$42.00

If rabies vaccination is not renewed and rabies vaccination expires prior to license renewal:

**1 year dog license:**

**3 Year (where eligible):**

### **Kennel License:**
