The motion was made by JJ Suarez and seconded by Javier Flores to approve Board Policy FM (LOCAL) to exempt all Advanced Placement (AP), Honors, and Dual Credit Courses in the subjects of English language arts, mathematics, science, social studies, economics, and languages other than English from the 70 average for eligibility purposes and set the standard for eligibility for these courses at a 60 average. The motion was carried unanimously.

The motion was carried unanimously.

The motion was carried unanimously.

The motion was made by Laura Perez and seconded by JJ Suarez to move that in the event that of a request of a non renewal hearing that the hearing be conducted by the Uvalde Consolidated Independent School District School Board, further move to authorize the boards counsel in consultation with the board president to impose procedural rules for any requested nonrenewal hearing and to make scheduling decisions regarding the same. The motion was carried unanimously.
