Police/School Liaison Interlocal Agreement Town of Little Elm and Denton ISD (August 14, 2018)

SUMMARY:

- This item requests approval of Police/School Liaison Interlocal Agreement between the Town of Little Elm and the Denton Independent School District whereas the town shall provide Denton ISD with two (4) certified police officers to serve as school resource officers (SROs) assigned to Navo Middle School, Braswell High School, Paloma Creek Elementary, and Bell Elementary.

PREVIOUS BOARD ACTION:

- The Denton ISD Board of Trustees have approved similar agreements with the City of Denton, County Sheriff's Department, and the City of Corinth to provide SROs to our campuses in their jurisdiction.

BACKGROUND INFORMATION:

- The opening of Braswell High School in Little Elm required the addition of an SRO.

- The annexing of developments encompassing Navo Middle School by the Town of Little Elm created a need to employ an SRO.

The offer from Water District 10 to fund two (2) additional SROs, one at Paloma Creek Elementary and one at Bell Elementary, created a need for Little Elem Police to train and provide two (2) additional SROs.
Water District 10 has also offered to pay for a police vehicle to be used by the Paloma Creek and Bell Elementary schools.

SIGNIFICANT ISSUES:

- The addition of campuses on the 380 corridor along with increased student growth necessitated the pursuit of an agreement with the Town of Little Elm to provide SROs. These schools are now under the police jurisdiction of Little Elm.
