Mr. Hipp stated that official notification from CMS was received in regards to a 15-months extension of the Medicaid 1115 Waiver-related Texas Healthcare Transformation and Quality Improvement Program. He further made reference to the detailed CMS letter dated May 1, 2016.

B. Receive Owner's Representatives update from Naismith Engineering, Inc., on construction of Dr. Hector P. Garcia-Memorial Family Health Center located on Hospital District-owned property at 2606 Hospital Boulevard, Corpus Christi, Texas - INFORMATION

Mr. Michael provided an update of the construction of the Dr. Hector P. Garcia-Memorial Family Health Center. He further stated construction is going really well despite setbacks due to the rain of two weeks ago. Project is approximately 65-70% complete; all mechanical and electrical work is completed and site work has begun. A site visit for board members could possibly be arranged within the next thirty (30) days. Estimated completion date is by the end of the year. Christus Spohn has agreed to maintain the green space for ten (10) years after completion of the facility. A brief basement demolition discussion was held relating to the cost for demolition and or to retain the basement.
