# **BOARD MEETING**

A special meeting of the Board of Trustees of the Aledo Independent School District was held on Monday, August 27, 2012, beginning at 7:00 P.M. in the Aledo I.S.D. Board Room with the following members present: President Bobby J Rigues., Vice President Jay Stringer, Secretary Johnny Campbell, Steve Bartley, Dr. David Tillman, and Hoyt Harris.

# **AGENDA**

President Bobby J Rigues, called the meeting to order at 7:00 P.M.

President Bobby J Rigues, determined a quorum was present at this time.

Vice President Jay Stinger led everyone in the pledge of allegiance to the United States and Texas flags.

President Bobby J Rigues declared a Public Hearing open at 7:01 P.M. for the purpose of discussing the budget and tax rate for the 2012-2013 school year.

Dan Manning, Superintendent, presented a combined budget of \$47,810,023.00 which includes General Fund, Debt Service Fund, and the Child Nutrition Fund for the 2012-13 school year. He announced that this budget is approximately 2.1 million dollars less than last year's budget and also includes an employee compensation package. The tax rate was presented at the same rate as last year's and has remained the same for the last five consecutive years at \$1.42 which includes \$1.17 M&O, and \$0.255 Debt Service for a total of \$1.425.

President Bobby J Rigues closed the Public Hearing at 7:04 P.M.

Mr. Dan Manning, Superintendent, reported:

  - ~ Enrollment The enrollment as of Monday, August 27, 2011, was 4,691 students.
- ~ Police Usage at District Events Superintendent Manning reported Police to people ratios have been researched and he will continue to study recommended safety standards for sporting events.
